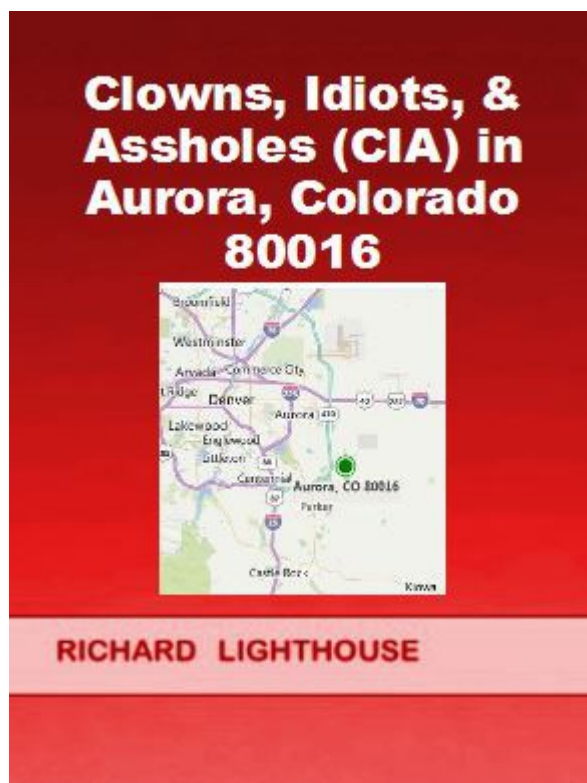

## Abstract

In the wide-open spaces of Colorado, who in their right mind would pay \$400K - \$500K for a house that was attached to another house? Does this seem odd? It only makes sense if the builder and property owner happen to be the Government, and your boss is the CIA. This short ebook documents the continuing fraud, waste, and abuse of public funds that is occurring at the CIA. In 2005, many newspapers carried a story stating the CIA's Domestic Operations were relocating to Denver. This sounded very odd as well.

Just like "Animal Farm" book, the CIA continues to believe they are entitled to special treatment and special privileges. "All animals are created equal, but some are more equal than others."

The CIA provides the funding to the Air Force Space Command for the Targeted Individuals program, which includes using microwave satellite weapons on civilians. ## **Introduction**

There is a significant amount of fraud, waster, and abuse of public funds that is occurring at the CIA. They continue to hide this corruption behind a fake wall of "national security." The misspent funds are being used to provide perks and fringe benefits for CIA agents, that they would not otherwise be entitled to. It is basically a bribe to purchase their silence about many

of the illegal activities of the CIA.

I have personally seen new homes up to \$850,000 provided to CIA agents in Houston (Camp Logan neighborhood, 77007), and memberships to the Houstonian private exercise club at \$25,000 provided to young agents. (The agent that received the most expensive home in Camp Logan, was a war vet that lost an arm, and then went to work for the CIA. That still does not justify fraud and abuse of taxpayer funds.) For the agents that were not interested in exercising, they were provided with other perks of equal value, like a covered backyard pavilion with a large screen TV, for drinking beer and smoking. It is nothing less than a bribe. I have seen the local CIA manager provided with a new Mercedes SUV, and two homes – one used as a residence and the other used as an office (6417 Westcott). The Russian embassy is a few miles away at 1333 West Loop South. There are about 50 to 100 CIA agents provided with these luxury accommodations at taxpayer expense, and this now appears to be common where ever the CIA sets up shop. Even Senators, Congressman, and Federal Judges, are not provided homes like this. In January 2015 and January 2016, I wrote many letters to Senators and Congressmen about this fraud. While living in Camp Logan, my home was broken into many times.

The CIA has continued this practice of bribing employees in Aurora, Colorado, which is the new Headquarters for the CIA's Domestic Operations. It also keeps them close to their prized program of satellite targeting of individuals from the underground city in Colorado Springs, at Schriever Air Force Base. The community housing in Aurora, used for CIA and Air Force officers, are a similar style to the housing that is provided on Peterson Air Force Base, for the senior officers. It appears to date around 2010. It is possible that these communities in Aurora were actually developed and constructed under a contract to the U.S. Government. The community names are Serenity Ridge, Tallyn's Reach, etc – zip code 80016. It appears this area was chosen because it is close to the park and the lake, Aurora Reservoir. I knew to look for this pattern, from my experience living in Camp Logan. However, the main difference in Aurora, is that hundreds and possibly thousands of government employees are being provided these ridiculous perks and bribes at taxpayer expense. In my opinion, this is the real reason the CIA moved to Colorado, because the obvious extravagance would not set well in Washington D.C.

It was the house of an Air Force officer that tipped me about it, Colonel Jacob E. Middleton, living at 26042 E Geddes Circle. His home was valued substantially higher (zillow.com) than any of the other Colonels working at Air Force Space Command. He was also the only one that lived an hour's drive away. In my opinion, he is an Air Force Officer and also reports to the CIA, just like Mr Scott M. Anderson. (Keep in mind, the CIA is hacking and altering zillow.com, and I have previously reported this.)

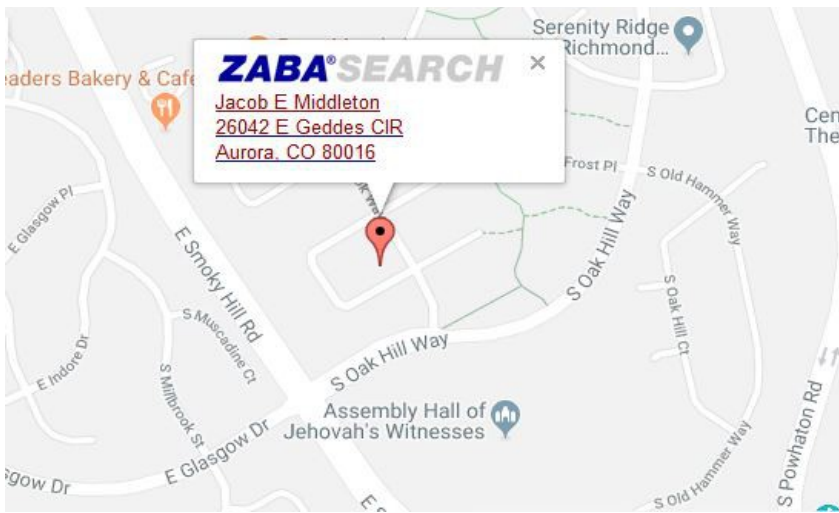
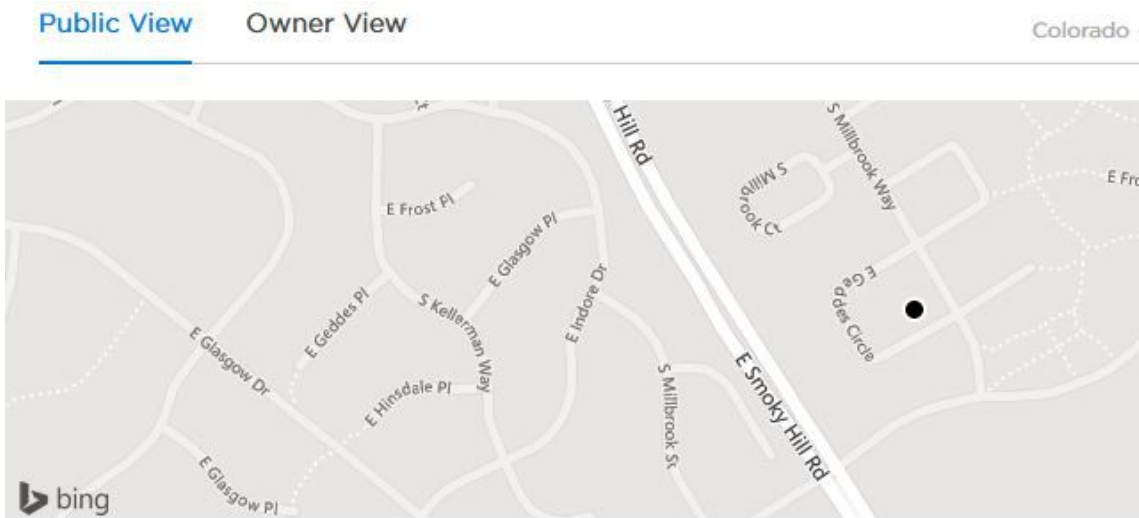


Figure 1. zabasearch.com

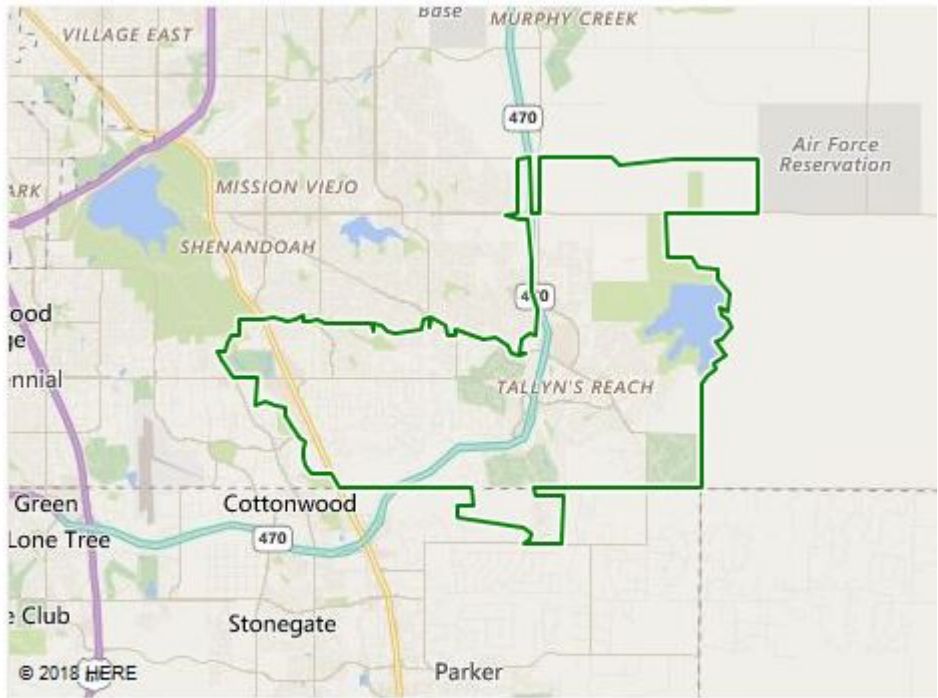

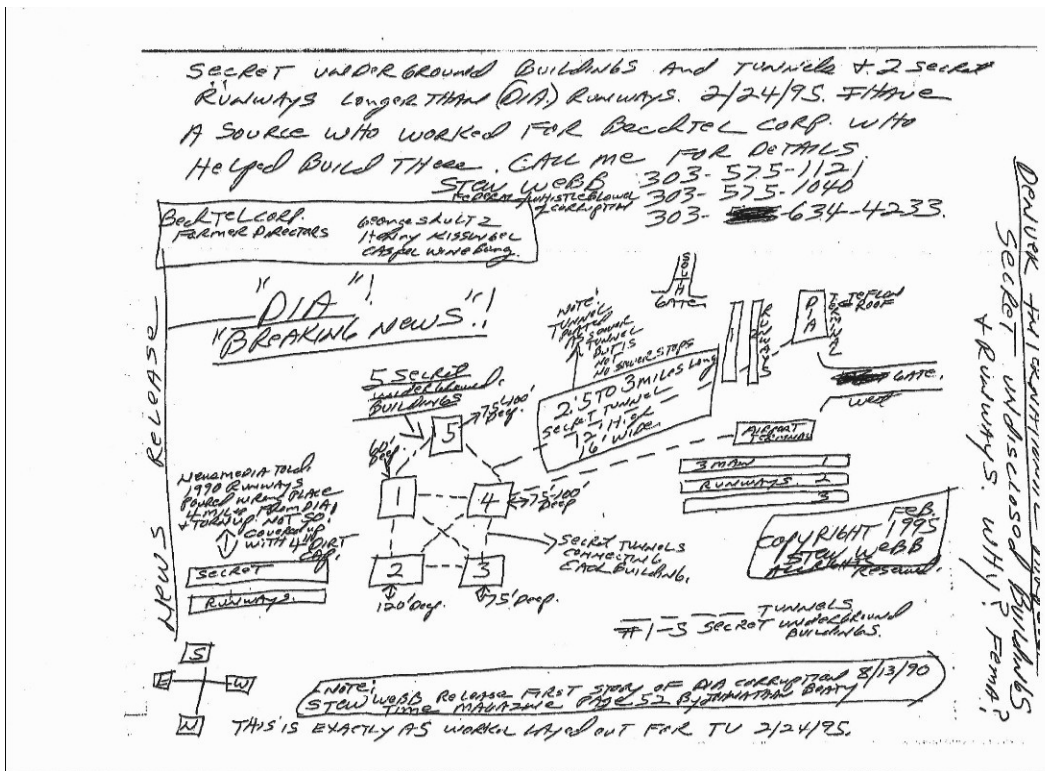


Figure 6. The rumored underground buildings of the CIA at Denver International Airport. Constructed by Bechtel, at a cost over-run of \$2 billion dollars.

I found an example of a new Wing Commander's introductory speech discussing the increasing suicide rate in the Air Force. According to this document, the number of personnel for FY 2013 for the CIA is 22,206. So we can state that moving the CIA's domestic operations to the Denver area, involved the relocation of thousands of employees.

Buckley Air Force Base is home of the 460th Space Wing and the 140th Wing Colorado Air National Guard, is Aurora's largest employer.

- Lockheed Martin Corporation	810

On July 20, 2012, Aurora was the site of the third largest mass shooting in terms of number of casualties in United States history, and the second-deadliest shooting in Colorado after the 1999 Columbine High School massacre.

In my opinion, it is not a coincidence that the CIA's move preceded the Aurora mass shooting. Under a CIA program called MK-Ultra, Dr Ewen Cameron, performed grisly electroshock experiments on patients, demonstrating that it is possible to turn someone into a mass murderer.
