On this 11th day of March, 2024. _____ appeared before me,
And individual known personally to me the person that affixed his/her signature to this document below and being first duly sworn on this oath, hereby deposes and says:

1. Hideko Go., is over of 18, and am fully competent in all manner to make this affidavit. I have personal knowledge of the facts herein, and if called as a witness, could and would testify completely thereto.

I have been a targeted individual for more than 30 years. I believe a result of government secret Non-Consensual experimental program. Completely thereto, my life has been so much disrupted from normal peaceful life.

In the last ten years, I have been attacked by a type of Electric Magnetic Weapon or Direct Energy Weapon. Completely thereto, these DEW weapons have profoundly decimated my health mentally and physically.

Following are the specific circumstances which I experience as a targeted individual.

I have had contact with FBI in the past.

My harassment started at Western Washington University in Bellingham (WWU), where I took a Computer Science Class in 1990-1991. (I ultimately changed my subject to Accounting and received a degree in 1993)

During this time 1990 -1991, I believe that the organized stalking and mind control program started. I believe that behind the computer, the WWU professor Ives might somehow have manipulated me or somehow mind-controlled me through show users like Junk email that he might have being aware of (the government Gang Stalking program.)

I believe that the professor somehow was able to monitor my behavior through a computer or camera in the computer lab. I was sitting the computer lab to finish my assignment for most of the day. To tell the truth, I was not ready for the computer science class because of my lack of mathematics, English and other factors. I got tired from not being able to finish the program assignment; I started to watch the show user like junk mail today often time. Soon I found that somebody was telling me something through the show user (Junk Mail). I become addicted to see so called messages. Unfortunately, I was being control by a manipulator that time. Following are some example of the Junk mail I saw.

HUGH: HG off from Japan. (HG is my initial of my name Hideko Go)
 HUGH: HI
 HUGH: HOTEL.... (I do not remember detail...)
 HUGH: How are you doing?
 HUGH: Ghost love. (It was just game. He has a girlfriend.)
 HUGH: Game is over (whenever the professor's girlfriend came to the town he wrote)
 HUGH: Marianne (I believe his girlfriend name.)
 HUGH: RUMER (I called other professor to find out whether the professor
 has a girl friend or not. Rumor among professors)
 HUGH: *No Way Out* (***Finally I learned what this means from the The terrorist
 Watchlist audit process 2008. my name will be forever in TSDB***)

There are hundreds so called messages. I wrote the messages on the notebook. After I found out he had a girlfriend in Oregon not Bellingham WA. I threw out the notebooks and tried to forget the incident but the Organizing stalking never stopped even now...

System: 1971 Whenever this Junk message is on show users, there was

System: 1971 is on.

I believe that this was from the professor Ive's account.

During this time 1990 to 1991, other harassment also started.

At my apartment I got annoying, lurid and harassing telephone calls for example, sounds of masturbating or heavy breathing on the phone call. I decided to moved out of this apartment and took apartment that one Japanese student had vacated. However the problem continued.

At my new apartment, somebody knocked on the door. When I answered the door, nobody was there. It happened many time even after I moved to other apartment. The neighbor's apartment often left door open and nobody was there or showed up at same time while I opened my door and was ready to leave my apartment. (This is typical mind control technic to inducing psychological trauma) I was studying for the exam at home and outside was so noise and it was almost impossible to concentrate. I was also studying at library every day. One SAME man came around me where I was studying many time every day. When I changed location where I was studying, the same man was continuing to come around me. After many years, I was living Seattle and walking at Alki Beach near my house, I saw the same man more than 10 times. He was running at the Alki Beach where I was walking. I believe that he was the person around me at library more than 30 years ago. I wondered that this was a coincidence or one of an organized stalking group of people. (I have written extensibly my experience. This is a shorter version)

I asked my friend at school 30 years ago, she told me that he was helping the boat club at WWU and member students (I am not sure about this but if I see a picture I can tell whether it is him or not). During my private time or when I was sleeping, I would hear a big walking noise below my apartment and it happened numerous times.

I went to the WWU Oversight Department to complain at the time but I was not resident (foreign) student and they told me to go file a complaint with the **FBI**.

This occurred during 1990 to 1991 while I was taking a computer science basic class from the Professor Ives at Bellingham WA.

An **FBI agent** came to my apartment at that time, I told him about harassment I was experiencing and annoying phone calls. He asked me who was doing it but I did not say the professor's name. Because, at the time, I had no way to know about Government secret Gang Stalking program.

One thing I remember is that the FBI agent told me was that he wanted to hear your voice.... He did not investigate any further and situation continued to get worse. I believe that I had already been placed the Gang Stalking Government secret program in the Non Investigate Subject of Terrorist Watch list. I moved to other apartment and to try avoid this type of harassment. Again, it got worse. Whenever I have "a private moment" or while sleeping time, I heard a noise like "Kan, Kan, Kan "Electric Magnetic pulse was hitting the old heating metal pipes. During that time I was studying Accounting for my degree and I gave up Computer Science. I stayed this apartment until I graduated in 1993. During 1993 to 1996 I was living at Tacoma WA. I was working at Korean accounting firm for about 1 year and another Korean Grocery store for another 1 years.

In 1996, I got accounting job at Japanese publication company at Seattle and I was living at down town Seattle Apartment. My apartment was a studio a apartment.

The worst thing was a big annoying gurgling noise from my sink sounding like "Pi Pi Pi..." An Electric Magnetic Pulse (EMP) frequency hit my window all night long made noise like "click, click, click.... (I was alone and scared during that time) I put hot water in the bath tub and I found full of some sort of gunk.

Many times I was walking in places near automobiles and I heard noise like "Kan, Kan, Kan" and I believe that perpetrator was using the Vircada system through satellite which produce EMF and hit the metal and made a sound.(I know now I was being attacked physically myself by the Electric Magnetic Force through satellite even when I was hiking mountain on every Saturday)

(Only people who allow to access the government secret technology are able to do that type of Attacks)

From 1996 through 1998, I visited the FBI Seattle office once. I met with a female officer and If I remember correctly she might have taken notes regarding the incident I reported.

In 1998, I had enough for the harassment on apartment. I decided to move in with nice Japanese lady and Sri Lankan husband in a house at Bellevue WA. I did not experience any noise problems. However, I got accident which was not my fault and end up I had surgery on my right ankle. I lived there about one year.

I moved back to Seattle and was living in a shared house with Japanese roommates. I had some problems but nothing significant. Between 1999 and 2008 in Seattle, I have encountered five accidents, small hit and run and some accident caused surgery one time and bloody nose another accident...(this is also an apparent Gang-stalking technic for harassment)

I married my husband on May 20th, 2006. It was happiest time of my life and I finally got sense of security even though there are some problems like lump on and off itself, telephone call Japan often problems, computer, refrigerator and thermostat,...hacking problems. But I was able to ignore these problems.

On September 2013, my life turned upside down. Unthinkable started happening where electric magnetic attacks to my body directly started occurring.

This followed after I received the WWU Alumni Magazine and information from WWU between 2010 and 2012 which my husband found out this. I had never received any pamphlet whenever I moved to. I was surprised about suddenly getting mail from WWU after graduating 1993.

I have my very detail records of journal about Electric Magnetic Attacks since 2013. Whoever would like to read these journals, I will certainly provide them.

The following section is a summary of these attacks:

- From September of 2013 to the middle of 2014, I experienced sleep interruption with an EMP remote pulse hitting my pillow whenever I fallen sleep. This lasted for almost one year.
- From the middle of 2014 through 2016, the EMF attacked my legs and ankles remotely. This lasted for two years (about 8 months rehab I had to take)
- From early 2016 to the present time, the EMF attacks have mostly struck my upper body (head, chest, face, eye, back) and all areas of body like foot, hips and finger including laser burned my face below left my eye. Also my right wrist was burned remotely. I took pictures. I believe that Nano weapon has been aimed to my organs like heart and lungs. I was coughing for false symptoms.
- My primary care physician, Doctor Okorn has all of my medical records for these unknown causes over the last 10 years. I visited Dr. Okorn numerous times in the past 10 years. She is available for any questions about my symptoms
- The concept of the EMF attack is now public knowledge with recent news of the incident in Cuba, where US and Canadian Diplomats were attacked remotely with EMF weapons at their residences and hotels where they stayed.
- I have experienced similar attacks. There are many advanced weapons available for these types of remote attacks.
- I believe that now I am feeling that my harassment became more like experimentation or testing for new advanced EMF weapons for DOD and the contractors who made and sell the weapon to company at US and foreign country and made millions if not billion dollar for these weapons.
- Some attacks I experienced were so painful and lasted for couple weeks. But eventually the pain would disappear.

- I am wondering whether this attack could also be a form of sexual harassment in addition to the invasion of privacy when I was naked or taking bath at the time.
- I am guessing that the painful attacks most likely came from near my house. This was in order to maximize the pain I was experiencing and it therefore needs to be closer to the target object. The EMF weapons are getting smaller and more compact. These weapons are easily able to carry. When the very powerful force attacked my chest, middle of night I was roaming around outside home in order to away from the attacks.
- The first 7 years of this attacks have been a nightmare, during which I was tortured in my sleep remotely. I went to the hospital emergency room two (2) times. I got suddenly really sick and went to the emergency room. However I could not see doctor because they were too busy on that night (I believe this was not true explained detail at my other write up)
- **I complained and reported these issues to the police officer at least 10 times.**
- **I believe that 2015, I visited FBI Seattle office with my husband. FBI agent met with us and asked me that do you have any physical burns on your body. At that time, I did not have any burns and so I said no. He also asked me that if you know who might be doing this, then you could complain on line. But I was not sure at that time there was a Government secret program.**
- On November 13, 2016 at 6:00 PM, my right wrist was burned when I was watching news. I went to see the doctor a couple days later. It took couple months for my right wrist heal.
- **I also called city of Seattle and other assistance organizations for their assistance, but they never investigated my requests or helped me out in any way.**
- **I called FBI couple times and cried out for help. But no body helped me. I was hopeless and wanted to die for the first time in my life.**

I visited Senate Patty Murray office many time but they did nothing. I also visited Senate Maria Cantrell office and recommended me to have Lawyer. I have a lawyer since 2022. But he has been still investigating.

My family became victims

In the last two years from (2019 through 2020), my family and relatives have also suffered injuries from unknown causes.

My husband has been victim for a while.

He had got attacked in the stomach more than few time while he was taking naps and sleeping in bed at night at home over time. It was excruciating pain and it usually lasted 4 or 5 hours and each time it mysteriously got better. (this is sign of EMF attack). The Doctor could not find any specific problem and told him just to the monitor situation. Also he got attacked Vancouver Canada hotel. When he was taking nap after long driving from the Seattle, he got attacked his stomach and experienced very painful suffering. I talked to the manager at the Pan Pacific Hotel about it. The manager has knowledge

about direct energy weapon. He suggested us that he could turn internet and cable off. But we said no. After that the attacks stopped.

After couple hours, he became normal as if it was nothing happened. The pain of this EMF attacks tend to be dissipated depends on its level of strengthen. At the end of November 2020, he had extreme pain on his teeth which was similar to my Problem. They were similar in nature. I explained his teeth problem in other write up. Teeth attacks have been very painful and costly problems,.

He also got attacked other area of his body but usually he does not complain. When it happened, he put ice pack around the sudden pain and removed when the pain had gone. This was last couple years of his life.

On 6/3/21 Thursday, he was working at home office. He got sudden pain in his Hip area. But he was still able to stand up and walking.

On 6/4/21 On Friday, he was still able to walk with some pain.

6/4 through 6/6, we went to Camping at Fort Townsend at Olympic Peninsula, his pain was start to getting worse. He was barely able to stand up and do function.

All he could do was that he rested and not walking because the pain became Unbearable. 6/7/21, on Monday he saw the doctor right away. The doctor examined and told him unclear or inconclusive. He did not have his hip pain before. This sudden occurrence was similar to my many problems I encountered during more that 10years. I believe that his pain is very bad but from my experience it will be cured in couple weeks if not couple days. Unfortunately he has been kept attacked and continued couple years. He had MRI 2 time the area but doctor can not find any problems!

Hideko decided to go public to expose this crime

On 2019, after I retired, I have intensified my research about this my injustice and suffering. The secret nature of government Terrorist Watchlist means that the general public are not aware of this unthinkable human torture and suffering program. Previously, I cried for help to public officials as described in my writing. However I have not received any support from them. Therefore ***I decided to go public myself.***

I joined the West Seattle Toast Masters even though I was very nervous and my English was not very good. This was to help my peaceful protest against injustice.

My 1st speech was about July of 2019. I had spoken about history of government Organizing stalking , history EMW and awareness of Electric Magnetic Weapon to innocent public. My 2nd speech was about September 2019

I filed Freedom of Information Act on beginning 2020

Hideko husband's family is also victim

During 1st and 2nd speech 2019, In order to pressure me, attacks against my families were intensified.

During this period, *my mother in law* had excruciating stomach pain middle of night (like my husband experienced), her neighbor friend took her to emergency but it was unknown cause even today. *I had been attacked many time at mother in law house whenever I visited her house. I believe that she also was victim.*

My brother in law lives in the Belgium. While he was riding his bicycle, he *lost balance*. He broke his arm and had surgery. It took more than 3 months to heal. I had similar incidents twice while I was running at Alki Beach near my house. Without any gap on the street, I felt pushed by Electric Magnetic Force (EMF). *I lost balance* I fell and injured with a very painful, bloody hand and arm. I saw doctor both time and there are records on the Swedish Clinic.

Hideko family in Japan is also victim

Around that time, *my nephew in Japan* was riding his motor-cycle, he also *lost His balance* and had an accident. I believe that this was similar incidents mentioned above. About Fall of 2019, *My sister* was telling me about having irregular chest pains and eventually they would disappear without see a doctor. I have been also experienced irregular chase pain for long time even present day. I saw doctor and had Xray and MRI and nothing was wrong. *I had been getting attacks my house in Japan. So I assumed my sister has also been victim.*

During the filing Freedom Of Information Acts on during 2020, my sister again said that she had experienced sudden dizziness and fell down. She cut near her head deeply and was injured. And again following weeks, she became dizzy and fell and cut her lips deeply. These incidents had happened on a weekend. She could not get any help from her brother couple or doctors. I went to a emergency room for 4 times and this always happened weekend. Two out of four incident were the similar to Vertigo and Nausea which American diplomats to Cuba and China, National Security Council at White House and Virginia have experienced. Now many science believe that these attacks are by Direct Energy Weapons.

I would call my sister once a week. On February 12 ,2021, she told me that she was experiencing sudden pain on near her waist on February 10 ,2021 and still suffering the pain. But after 3rd day, she got a little bit better but she felt that she was still in pain. I told her to see a doctor. I called her one week later (on February 19, 2021). I was glad that she was back to normal. This is exactly a sign of EMF attacks.

During the summer 2020 while I was filing FOIA, my brother in Japan, he *lost his balance* or something unfortunate happened to him. A very heavy piece of steel or some type of metal dropped on his foot. He suffered a broken foot and had to have surgery on it. It took couple months to heal his foot.

In 2021, when I appealed the FOIA request, my sister Tokyo became victim. She encountered sudden pain in her body. She went to see her doctor right way to find out problems. But like me, her doctor could not find any problems. She started to experience panic attacks and could not control herself. She has been taking her depression drugs and can not stop the drug even now. It is a tragedy!

I told my husband's sister's a couple of these about my problems long time ago because they area accomplished professor and security analyst to the government respectively. I respected them. But they are same as others who do not aware of this DEW and secret government program. However after "Havana Syndrome" broke, my sister in law sent me couple articles.

I have not told to my family about my targeting by DEW. If I tell my family about the attacks, they would disown me! However, whenever I call Japan, I educate them to turn off the cell phone if possible and tell them to live happy and joy. Also, I have been sending encouragement from Buddhism for last three years to my depressed sister every day.

For more than five years, my attacks have been primarily in the upper body mostly my chest. I got more than enough torture in my chest and usually it happened at night just before I went to bed or was in bed. The torture was lasted about an hour. I got out house in order to avoid the attacks. The next day or during the torture I went to police station and reported it. I have couple case number but the cases were never investigated. One officer told me that other victim also came to the station so that he sympathized me and listened to my story. Now whenever the torture happens, I report police officer. Unfortunately, after police budget cuts, there is no walk-in police station customer service a around us. I had to call non emergency telephone line. I did so many time. The most recent experiences were January 14th, and 20th 2024.

Because of these repetitious chest attacks, I have experienced pain in my chest all the time. I saw my primary doctor countless time over the last 10 years in order to check my chest and other area. But she told me that nothing was wrong. My primary doctor finally gave me referral to Pulmonology doctor last 2023. I saw the Pulmonology doctor. She thought that I might have the cancer and told me to have CT scan and Pet scan and I did. After the Scans ,the doctor told me that I do not have cancer, but there are multiple solid and groundless non-calcified pulmonary nodules with largest 11x7mm nodule right middle lobe, 2x3mm right, 2mm right lower lobe, 6x5 groundless medial basal right lower lobe, 3mm left lower lobe and so on....in fact there are multiple non- calcified nodules spread all over my chest! I was recommended to consider CT scan every 3month. I believe the result from countless DEW attacked to my chest. I had surgery last July 2023 and she cleaned the affected area in my chest. If I do not get attacked, my chest is very normal and there is no pain. However, even after surgery, I have

been attacked my chest again and again. This January 2024 I had Ct scan, again there are appearance of multiple solid and groundless pulmonary nodules Also, there is a new cluster of reticulonodular densities in the lingual likely infectious/ inflammatory. This can be reassessed on follow up imaging. (I believe that this inflammation occurred 1 weeks before this CT scan, I got tortured twice in my chest on 1/14 and 1/20/24. I called the non emergency police so, there are recordings of my phone calls. I will see the doctor on end of April 2024 about this issue.

I have another concern other than chest and other area like head attacks, my eye have been slowly damaged. I got bad attacked on my right eye couple years ago continuously. My eye doctor told me this year eye examination, my right eye some cells were dead, if continue this pace of attacks, I will lose my right eye sight at age 85. I am 70 years old now. During last two weeks I was preparing this Affidavit, I got attacked my eyes while I was sleeping, noting I could do except medicate my eyes. I also experienced deep chest and upper back pain which caused me to walk with limp!

I have written about these attacks in a journal every year for last about 7 years. If anybody wants to see them, they will be available.
