AFFIDAVIT OF CHRISTINE GRANTHAM

An individual known personally to me the person that affixed his/her signature to this document below and being first duly sworn on this oath, hereby deposes and says:

- I, Christine Grantham, am over the age of 18, and am fully competent in all manner to make this affidavit. I have personal knowledge of the facts herein, and if called as a witness, could and would testify completely thereto.
- I. I earned an AA in Fine Art from San Jacinto Community College in 1992. My studies in multi media materials was ongoing from 1975 through present day. My art studies were made at Western Nevada Community College. I received a Best in Show award for a drawing and 2nd place for a watercolor painting at Western Nevada Community College.

I consider myself a law abiding citizen and a decent woman. I am 72 yrs of age and disabled . I have a heart condition and a pacemaker. Ive had the pacemaker since devastated by the horrible life style I have been subjected to, since approx. Dec. 2018.

I know absolutely nothing about terrorisms' agenda upon others. I have seen a cover page about me, when I searched my name; person, saying that there was some kind of suspicion about me. I called Truth Finder; company that was doing the search, and they said "It has to be the Government".

2. I became homeless at the age of 67 yrs. A series of unfortunate events happened and found myself living in my SUV vehicle. A friend of mine lived in Paramount, Ca. and I went there for a short time and then to Belmont Shore Long Beach, CA., where I resided in my SUV adjacent to other homeless individuals with campers, cars and suv's. I found out approx. 2 months later that the residents were being abusive towards us individuals that were across Ocean Blvd, which is a public parking area. Police were seen going through the area of the beach and Ocean Blvd, Long Beach, CA. Police did not protest or stop to say anything to me regarding parking there. About this time my service dog had jumped out of the window while driving and a resident offered to help me find her. She put me on the Next Door App. And successfully I found Ruby; my Service dog.

The other campers in the public parking area were apparently having some issues with the residents across Ocean Blvd, and one was an acqaintence of mine; June Whitney. We were reading some of what the residents were saying about us, on the next door app.

I didn't document this particular mans name or statement, but he was making statements about hurting the homeless with baseball bats. He also stated that he was going to slash the homeless peoples tires.

Within this time period of 2018-2019: I was parked there for 6 months. Strangers began to harass me, mostly men. They would knock on my vehicles windows, call me bitch, throw coffee on my vehicle and swing their arms close to my face. It was an unbearable place to be. June Whitney began talking to me about people stalking and harassing me. Chris Grayson, another acquaintance, came to me saying the same thing, dialog in the form of a warning. Chris Grayson says to me "You are going to be followed for 1 – 2 years. Both June Whitney and Chris Grayson are from Long Beach, CA., according to what they stated to me. My life there was unbearable, I was being threatened everyday. I fled the area and decided to travel some of California. My Grandmother was buried in Santa Rosa, CA., that was my ultimate destination. I was harassed, everywhere I stopped along the way. Santa Cruz was beautiful and there was church parking for the homeless. Even so, these horrible individuals harassed me everyday. One day while parked enjoying the walkway overlooking the ocean, a group of individuals were getting physically close to me, I decided to get into my vehicle, I was abruptly stopped by a women as she put her phone into my face as if taking a picture of me. I had my landyard with keys in my hand to escape this group and female that was actually touching my nose with her phone. 2 people that were standing with her got closer to me, I was terrified. I pushed the phone out of my face. Within minutes, the police were there and hand cuffing me. They took my service dog to a shelter and took me for 24 hrs observation. I had before this assault reported another 2 individuals that were bothering me to the police. That time a policeman told me "Leave the State" I was so humiliated, the way I was treated like a criminal. I was held for 24 hours, picked up my Service dog who became ill being in the shelter, and left Santa Cruz, CA.

- 3. I obtained subsidized housing at 1738 S. Santa Fe Ave # 803 San Jacinto, CA 92583 on 12-1-19. Within a few days a resident here PE PE began bothering me . Anytime I was on my patio, he almost always came by, stopped and talking about how trustworthy he was. I would see him at the store, almost anytime I was there. I was interrogated: harassed by Marco Lemus, property manager of San Jacinto Manor. After moving into # 803 , he repeatedly asked me "what did you complain about at the last place you lived?" He asked me this on two different occasions. I was frightened of him and my residency and so replied to Marco Lemus "I wont complain" On July 30, 2020 @ 9:30 pm, James Mc Gee san jacinto manor apt # 901 jumped out of his wheelchair and ran towards me and another resident , yelling bitch repeatedly. I was terrified. Next day I called the sherrif's station and the sherrif talking with James Mc Gee , then the Sherrif came to me at my apt. I received a section 8 voucher and asked for Marco Lemus to accept my voucher, he refused. I moved out at San Jacinto Manor on 12/10/20 .
- 4. I moved into Brooke Terrace apts at 335 n Circelli Way # 4 Hemet, Ca. 92545 on 12/10/20. In 3 days Michele Crow in apt 9 and another person, waited on the sidewalk and stopped me, both trying to get my attention. Michele Crow I believe has participated with gang stalking pertaining to other tenants, but the most proof I have that she had tried to ruin my reputation, is that she told Lois Teal, who I became friends with, while pointing at my apt. saying "Watch out for her! "I believe Michele Crow was participating with other tenants to harass me. Michelle Crows friends Steve Burton # 25 and Jacqueline D Anderson # 7 Steve Burton after I moved in, began walking past my apt. looking in, smiling, waving at me from across the parking lot. I felt the need for a restraining order, filed but didn't go to court The reason I didt pursue the restraining order is because by that time, I was feeling threatened by management. The manager had already asked me if I had somewhere I would like to move. Jacqueline said to me "here comes the crazy lady", while getting my mail "You take drugs" and "get a life", she followed me into goodwill inc. I again took a step to stop this harassment and told the manager if Jacqueline did stop stalking and harassing me, "I was going to get a restraining order against her"

5. Approximately 3 months into my residency at Brook terrace Apts 335 n. Circeli Wy # 4 Hemet, CA. 92545, The manager Stacy Olsen came to me with a video on her phone. The video showed a man walking around my vehicle, looking in windows. She came to me a few days later with another video of the vehicle in the first video exclaiming to me "The vehicle has been parked across the street for days.I was hoping that somehow all this stalking and harassing by strangers and other tenants will stop, but it was happening more that ever. On Jan 7, 2021 I shopped at Green Tree store in San Jacinto with my service dog Ruby. About 2-3 people came in and one followed me in the store. In the store he leaned into my face and said "Im going to mess you up" I was terrified and said out loud "call the police'. Police came after the man followed me out of the store, kicked Ruby, my service dog, she fled and never found her. I did flyers and searches, I never found her. The police did nothing to this man. The police told me, there is a pandemic, cant do anything right now.
