

AFFIDAVIT OF ISIDRO ABASCAL MONTALVO

On this 20th day of June, 2023, Isidro Abascal Montalvo appeared before me, an individual known personally to me the person that affixed his signature to this document below and being first duly sworn on this oath, hereby deposes and says thereto:

I, Isidro Abascal Montalvo, am over the age of 18, and am fully competent in all manner to make this affidavit, I have personal knowledge of the facts herein, and if called as a witness, could and would testify completely thereto.

1. I am a 70 years old man who has lived 43 years in NYC. I am a college graduated: an Associate in Arts and a Bachelor of Science in Legal Studies. I am currently working as a security officer. Also, I have multiple certificates of achievement while incarcerated and after release.

2. On October 12, 1995, I was arrested for a drug related offense and placed in Rikers Island, NY. However, I believe January, 1996, was when I believe all this remote electronic assaults (Havana Syndrome) and organized stalking started. Therefore, for 27 years, I have been subjected to cruel, illegal, and covert human experimentation in the Targeted Individual program.

3. I have been the victim of gruesome Directed Energy Weapons (DEW) attacks (Havana Syndrome) and organized stalking for almost three (3) decades 24/7. See *Abascal v. Hilton*, No. 04-cv-1401, 2008 WL 268366 (N.D.N.Y. Jan. 30, 2008); *Abascal v. Jarkos*, 357 Fed. Appx. 388 (2009); *Abascal v. Jarkos*, No. 08-0789-pr. (2d Cir. December 21, 2009), aff'd; *Abascal v. Jarkos*, 559 U.S. 1116 (2010), petition for cert. denied.; and *Abascal-Montalvo v. The City of New York*, No. 100112/16 (N.Y. Sup. Ct. Dec. 3, 2018); *Abascal-Montalvo v. City of New York*, 179 A.D.3d 620 (N.Y. App. Div. 1st Dept. 2020), aff'd; *Abascal-Montalvo v. City of New York*, 35 N.Y.3d 976 (2020), 2020 NY Slip Op 66873, motion for leave to appeal denied (N.Y. June 9, 2020); and *Abascal-Montalvo v. The City of New York*, 141 S.Ct. 664 (2020), petition for cert. denied.

4. These remote electronic assaults, DEW attacks (Havana Syndrome) have caused me wanton and unnecessary inflictions of pain, and extremely horrible experiences, including, but not limited to: most of the time (24/7) my genitalia are compressed to a baby's size which hinder my sexual functions; and innumerable serious physical and mental injuries, and psychological damage, including, numerous concrete disfigurement scars all over my body, e.g., cigarette burn type scars; darkened skin in my head, face, neck, chest, hands, arms, legs, feet, thighs, waist, abdomen, making me a multicolor person in different parts of my body; corrugated skin in parts of my body that are different as the normal aging process; hot-needles-pushed into flesh sensations; general pain all over body; wildly racing heart without a cause; violent no-rash itching with preference for hard-to-reach-areas especially when trying to sleep; intense itching; microwave burning and hearing; artificial tinnitus (ringing in the ears); muscle pain and muscle

quaking and other unexplainable vibrations all over my body, including the anus; sleep prevention occurring at precisely the same time or waking me up about five (5) hours after going to bed for decades; fake noises and knockings through or on walls; and painful cut sensations in my fingers every night while flossing my teeth for decades making believe that the flossing thread is cutting my fingers.

5. Additionally, microwave burn and electrical shock sensations; multiple wheals all over my body; pimples, skin eruptions, bumps, craters, deep pores and nicks in my face (I never had bad acne as a teenager and whenever I had a pimple in 2 days was gone without leaving any scar); blurred far sight and blurred near sight when reading; tingling and hot-needles-pushed into flesh sensations after shower every day for years; bulging veins leaving a diamond shape scar in the middle of my forehead; scrape sensations in my face leaving scraped clean down areas with patches of facial hair rooted out, which developed wheals, craters, deep pores, nicks, lumps, whiskers ingrown and black heads; microwave burn sensations over right and left temples and around the outer corners of my right and left eyes which left wheals that later became furrows like crow's feet; microwave burn sensations on my face which later became craters chicken pox type scars on my face; brown burn type scars in my legs differing in size and shape; scrape sensations parallel with old wound scars which enlarged the size of those wound scars in my head and in my left eyelid; microwave burn, scrape and electronic shock sensations on my right cheekbone that left a line of craters and nicks which later became a little scarface in my right cheekbone; and microwave burn sensations over my temples and the nape of my neck leaving patches of my hair burned clean down and rooted out receding and making my hairline uneven with patches gone on those areas. And I have also been induced to sleep while driving in the expressways.

6. The organized stalking against me has involved, including, but not limited to, multiple individuals who stalk, and harass me in the street; cars are most of the time parked outside of my building with persons looking at me when I leave my home to intimidate me; almost every time the same neighbors leave or arrive at the same time as I do; people in the street stare at me in a leering or mocking way, usually with a smirk on their faces. Also, in my job, people say things to me that refer far too specifically to something within my private life, an effective way of letting me know that I am somehow under surveillance without actually doing anything illegal. I have sometimes experienced intense harassment while driving, e.g., tailgating; being cut off in traffic; hostile gestures; and perpetrators have tried to run me off the road by crowding or mobbing me with their cars. Family's, friends' and love affairs' relationships went sour without me doing anything to cause that. Repeated evidence of enters in my home and large and small scale of sabotages and vandalizing of personal property and car; computer and mobile phone hacking; surreptitious entries into domicile; tampering with postal mail; spreading false and defamatory rumors about me in the neighborhood and work place to attain my virtual ostracizing from society; and innumerable disputes, arguments and confrontations with people in the street and in my job which have cost me losing my job or being transferred/reassigned to another site; and mortification, personal humiliation, mental anguish, and emotional distress.

7. Even DOCS and NYS Dr. Marvin Rabinowitz participated in this horrible program by ripping my anus external and internal anal sphincters causing my hemorrhoids get torn out of my anus by improperly and maliciously, and in such a rough manner that I flinched in pain on doing

a prostate examination sat down in a table, instead of, standing and bending forward at the waist or lying on my left side, with my knees bent toward my chest. See *Abascal v. State of New York*, 19 N.Y.3d 805 (2012), 93 A.D.3d 1216 (2012).

8. There were other inmates in the correctional facilities that I was at who had the same ill effects and types of body scars that I had and still have. Due to these remote electronic assaults, DEW attacks (Havana Syndrome) microwave burns, my body has become a multicolor body ranging from originally Caucasian to brown/tan now in different parts of it.

9. Whenever I sought medical attention for the aforementioned symptoms, the only further action any prison or street doctors took with respect to my physical injuries and allegations was to advise me in asking for mental health treatment, change soap, stop putting lotion in my face, stop wearing boxer underwear, and classify me as delusional.

10. In the beginning, I attributed these events as normal life events because I did not know, but on August 6, 2000 was when I realized I was remotely and electronically assaulted, and a victim of a gruesome and horrible experiment because I was hot-needles-pushed into flesh sensations tortured with excruciating stings that repeatedly/constantly lasted for approximately 15 minutes nonstop in my chest.


11. I was paroled on September 13, 2005 after ten years in prison, but the incidents did not change, but increased in severity, even when I have been free for 18 years now.

12. I have written letters for help to US Presidents (William J. Clinton); US Senators (Charles Schumer and Kirsten Gillibrand); US Representatives (Charles B. Rangel and Adriano Espaillat); and innumerable of other politicians and organizations to no avail.


