

## AFFIDAVIT OF TRUTH

**I, Donald-Anthony: Bratcher, TTEE**, am over the age of 18, and am fully competent in all manner to make this affidavit. I have personal knowledge of the facts herein, and if called as a witness, could and would testify completely thereto.

### FACTS:


1. I am a high-school graduate with some college experience.
2. I have been a photographer of passion and trade since my graduation from RICHLAND HIGH-SCHOOL in Richland, Mississippi where I still call home.
3. I have held most Front Of The House positions and some Back Of The House positions in the food service industry for approximately thirteen(13) years following my graduation from high-school. In my experience with people during this time, I developed exceptional interpersonal skills and refined comprehension of social dynamics as well as calibrating reactions of individuals in social interaction. Understanding non-verbal communication, body language and other subconscious indicators apparent in individuals' physical responses as well as group response was necessary in order to maximize income potential and give my customers quality service. Simply put, I recognize when behavior is out of the ordinary.

On May 9<sup>th</sup>, 2018 due to rampant fraud throughout the UNITED STATES government, I filed a UCC-1 with FLORIDA SECURED TRANSACTION REGISTRY(20180535890X) for the primary purpose of separating "I" from the CESTUI QUE TRUST fiction created, without my natural parents' knowledge at the time of my inception, with the legal name DONALD ANTHONY BRATCHER.
5. In February of 2018 I became aware that I was being followed everywhere I went by all types of vehicles with out-of-state license plates, mainly from TEXAS, LOUISIANA, ALABAMA, GEORGIA and FLORIDA as well as an abnormally high number of temporary tags and dealership tags. At this particular time I was employed as a driver for "WAITR" a food delivery company that uses an application for mobile devices for customer interface.
6. I was working for WAITR delivering food when I realized I was being followed everywhere I went.

7. I have been harassed at home by neighbors, HOA of my neighborhood, neighborhood groups, local law enforcement, as well as my own family.
8. I have found proposals and grants to allocate money to send police officers to technological surveillance courses, RFID seminars and purchase the technologies for intercepting communications etc.

Perpetrators have trespassed onto my property, put out security lights, entered my home while sleeping and out of the house, severed high pressure hose to my truck's air conditioning, poisoned me and my dog which died as a result(a friend's dog died at the same time with the same symptoms), I buried both of our pets on the same day.
