

AFFIDAVIT OF Michael Entress

On this 02 day of July, 2018, Michael Entress appeared before me, an individual known personally to me the person that affixed his/her signature to this document below and being first duly sworn on this oath, hereby deposes and says:

I, Michael Entress, am over the age of 18, and am fully competent in all manner to make this affidavit. I have personal knowledge of the facts herein, and if called as a witness, could and would testify completely thereto.

1. On or about February of 2014 till on or about June of 2015 I utilized my Veteran benefits at the Lyons, New Jersey Veteran Affairs campus. The Veteran benefits I utilized include but was not limited to was Community Hope for Veterans and the Veteran Industries Vocational Rehabilitation programs.

2. During the later half of my stay while at the said above (1) I became a Targeted Individual for Direct Energy Weapons, Psychotronic Assaults, Electronic Harassment, Remote Nervous System Monitoring and Manipulation, Government sponsored gangstalking, Workplace Harassment, and Sexual Harassment. During this time I participated in the Veterans Industries Vocational Rehabilitation 'Compensated Work Therapy' program. I was given the assignment of the office clerk for roughly a year. While on this assignment as the Office Clerk I was provoked, stalked, and sexually harassed by government employees.

3. One of Veterans Industries Coordinators; Kathy Sweeney, on a regular basis referred to me as her "Hopeless Case." The same individual regularly (on a daily basis) would hold her cell phone in a vertical or up-right position of her hand and focused toward my direction; as if trying to take my picture. In addition, at the end of the work shift, I shut off the lights of the outer lobby in the office routinely. This particular day Kathy Sweeney sexually propositioned me by waving her hands and arms toward her breasts. She said nothing, but motioned me toward her breasts.

This event was the indicator that made me realize all those times mentioned above, and including those times I went to the mens room, her coincidental presence, standing out in the hallway; like clock work, was no coincidence, and that I was being stalked by a government employee.

I was very upset about this incident; the behavior displayed by a professional, and one of my bosses. I proceed and left quietly without saying a word until I met with my counselors with whom I shared this incident with.

4. The other Coordinator of Veteran Industries; Kurt Hanscom, during the same time, on a daily basis, would provoke and harass me. As one of the Coordinator's of Veterans Industries Vocational Rehabilitation program he reassured me that I will be eligible for Disability. At the time; I was fresh out of jail, fragile, servile, eager to regain the publics trust, and in search for a new life to start. I often wondered to myself; then, "Why am I in this program?" I was afraid to

question my Coordinators actions or words! In addition, Kurt Hanscom often would provoke and harass me by calling me names such as; "Outlaw" and "Renegade."

5. I blew the whistle and reported corruption at the Lyons, New Jersey VA campus to the VA Inspector General Hotline, on the basis of issues related to Privacy and sexual harassment.

6. It was during this time when I realized the signs and symptoms of being a Targeted Individual for abusive and tortuous Direct Energy Weapons and Psychotronic assaults. Although I was being targeted, I completed the programs and made my transition out into a neighboring community; where and when the electronic weapons intensified.

7. My Veteran Affairs Doctors are falsifying my health chart by misdiagnosing it as secondary to a preexisting health condition.

I declare under the laws of the United States and the State of New Jersey that to the best of my knowledge and belief the information herein is true, correct, and complete.
