I am writing this letter to you about a very serious matter on the behalf of my wife Bonnie S. Kellerby, because she has been trying to get help with a problem that is not understood with the Medical Community due to its unusual symptoms accompanied with a typical diagnosis. If you will please be open minded and read this letter keeping in mind how terrifying this would be to go through as my wife has for the past 6 years. The situation did not improve after we were able to settle into the motel room and about 10:00PM I convinced her that we had to go to the hospital and see what they can tell us. She was checked out physically including a brain scan and everything seemed to be OK, but the distress and description as to what was going on resulted in admitting her into the psychiatric clinic for observation for a minimum of 72 hours. Typical diagnosis for the symptoms, this did not go over very well with Bonnie, but I could not keep them from proceeding with this action. So Bonnie went through this horrible ordeal and after just a 2 1/2 day stay she was released proving to the doctors that she was mentally stable and there were no indications otherwise.


