## AFFIDAVIT OF ROBERT EARLE WOOD

State of Minnesota County of St Louis

On this Zata day of May, 2019, Robert Earle Wood, appeared before me, an individual known personally to me the person that affixed his signature to this document below and being first duly sworn on this oath, hereby deposes and says:

I Robert Wood am over the age of 18 and fully competent in every way to make this affidavit. I have personal knowledge of, and experience with the facts stated in this document, and if called as a witness, could and would testify completely thereto.

- 1, My name is Robert Earle Wood also known as Bob. I come from a well-educated family and grew up primarily in upper middle-class neighborhoods around New York City. My Father worked in NYC. I studied music, both publicly and privately growing up, and worked as a musician professionally for about 10-years. I traveled throughout North-America during that time. I have attended 2-community-colleges and a computer training school. I have worked extensively in the building-trades and was a self-employed contractor. I am an excellent researcher and have done extensive research in the fields of religion-and-philosophy among other topics of interest. I have managed my parents' estate and affairs through their deaths and kept my mother out of an institution for 6-years before her death. I have also walked up countless mountains in New-England, The-Rocky-Mountains from Colorado to Western-Canada and the Pacific-Northwest. I have gone into wilderness areas. I have done various community-public-service work. I meditate and do spiritual-work.
- 2, No-one in my family has a criminal record that I know of.
- 3, I have no criminal record.

- 4, I am not a terrorist.
- 5, This Affidavit is basically a synopsis (not-complete) of my experience of being a Targeted-Individual in The United States of America for the last 18.5+ years. It is basically chronological though the chronology is not perfect.
- 6, In the year 2000 I made an arrangement with my parents to help them in their old-age. An arrangement that was beneficial to both parties. I received a small sum of money plus room-and-board in exchange for my many services. This was a big comfort for my parents in their old-age and allowed me time to get into the mountains and pursue my study and research. The family home was in Fairfield, Connecticut.
- 7, Around this same-time I applied for some free-"counseling" at a place called "Fairfield-Community-Services" in Fairfield Connecticut. The purpose of this counseling was to get help/advice in the management of my parents and their-affairs in their old-age. I received the counseling I requested, but much more as well, as this "counseling" was used to gain much information about me and build the psychological-profile used to attack-me later-on(I believe my counselling-sessions were recorded without my knowledge). The "Supervisor-of-Counselors" there was a Professor-of-Nursing and APRN, EdD, CS by the name of Dr Doris Troth Lippman. Dr Lippman was a Captain in the army and has an extensive military background. I believe this woman had a lot to do with my targeting. I now personally view her as an evil-criminal-psychopath.
- 8, THE-TARGETING-BEGINS: In the fall of 2001, just after the events of 9/11/2001, I started noticing some "odd" occurrences happening to and around me. I was being "checked-out" at trail-head-parking lots by the police, mostly Connecticut-State-Troopers. I then started noticing "objects" being "left/placed" inside the cab of the pickup-truck I was driving, which had been locked at the time. Also, "objects" being left around the truck. I thought this odd and remember feeling some fear and feelings of violation but didn't think too-much more of it at the time.
- 9, The first time I remember this happening was at a trail-head parking-lot at St.-Johns-Ledges, along the Housatonic-River in Kent, Connecticut. This happened many times at that location and other-locations.

- 10, I started noticing these same "objects" (pieces-of-paper, some with writing on them, wrappers, cans, bottles, cups, garbage other things etc...) being left everywhere I went. I was starting to become concerned. "Something? was going on!" They were usually the "same-objects" so it seemed obvious they were being left there for me.
- 11, The next major event I remember was... I had some items stolen out of the room I was sleeping in, in the family residence. Also, my personal possessions showed signs of having been gone-through by someone. My books, personal-papers, journals etc... had pages folded were marked in various places and in some cases were missing. Other items were moved around. Things from my wallet, keys etc... disappeared? Also, the "objects" were appearing INSIDE the residence now! I talked to my parents, as they were the ones I was living with at the time and they knew nothing about it?
- 12, At this point I was really concerned. Something was happening! But I had no-idea what was going on?
- 13, Things continued to escalate. All these events and more were happening multiple-times a day. There was nowhere I could go and nothing I could do without "something-happening". I was becoming very-negatively impacted all-the-way-around. Mentally, emotionally, psychically, spiritually and physically. I was becoming physically sick at times. No-one I talked to knew anything about it or could offer any explanation.
- 14, One day as I was driving back from Massachusetts to Fairfield on Route-8 in Connecticut, around Waterbury, a Connecticut-State-Trooper/Police-Car pulled directly in front of me and drove very slowly. I had to slow-down. Again, he was directly in front of me and close. When I looked at his license-plate it read REW-149, my initials and house number! I was shocked and horrified! A wave of fear and terror shot up through my spine. This happened at-least one more time on the same road about a week later.
- 15, As the targeting progressed many vehicles including Crown-Victorias would pull in front of me and drive very slowly. It was obvious these people were trying to give me "messages" via the license-plates. This combined with everything else that was happening terrified me. I tried not to look at the plates.

- 16, Over time I was able to discern the number-system as 1=A, 2=B, 3=C, 4=D, 5=E etc... down-the-line.
- 17, I had vehicles try to run me off the road many times. I had vehicles "surround-me", "box-me-in" while driving. I had vehicles start to "pull-out" in front of me only to pull-back at the last minute, I would have to react! I had vehicles drive towards me on the wrong-side of the road at night with their lights-off. I had vehicles drive towards me the wrong-way on one-way-streets. Many more incidents. These events were happening on a daily-basis. More events like this then I am capable of remembering. Very-stressful!
- 18, Everything I did inside the residence I lived in(family-home) was subject to "feedback". I obviously had no privacy. I went to great lengths to try and secure the residence but was unsuccessful. Every-time I left the residence "someone" would enter it and move, mark, break or steal things and leave me threatening messages. My life has been threatened more times than I can count. I was living in, in-essence, an ELECTRONIC-CONCENTRATION-CAMP! No Privacy! and not secure!
- 19, The "ways" which messages were left were many-and-various i. e. cans, packages, containers arranged or torn/ripped in ways that exposed letters to produce words. Pieces of garbage, wrappers, cans bottles etc... with numbers and letters exposed to create words and-or-messages. Sometimes words were even "written-down" on something with pen-or-pencil, Graffiti! And of-course the license-plates. Other-methods as well.
- 20, I did not know it at the time but I was being "sensitized"(Pavlovian) to a number and letter-system and "Harassment-Protocol", for lack of a better-term. This system was in conjunction with the license-plates and other tactics used by my perpetrators. Terrorists!
- 21, My vehicles were entered and items/parts moved, marked, broken and stolen, just like the residence. The vehicles were vandalized, parts stolen, scratched and more.
- 22, If I went to a store to buy something it would be gone from the shelf.
- 23, I was living in a state of terror! I was being terrorized!

- 24, "Some" but not all of the tactics being used against me were/are:
- A, 24/7 surveillance, including my vehicles.
- B, Constant-feedback from that surveillance. To let me know I'm being watched and to cause psychological-damage.
- C, Followed, watched, harassed and or assaulted everywhere I go.
- D, Residential and vehicle break-ins or home/vehicle invasions.
- E, Phones taped and hacked.
- F, All communications monitored.
- G, Mail tampering.
- H, Computer hacked.
- I, Harassing phone-calls.
- J, Vehicle-tampering and vandalism: including, but not limited to, water removed from the radiator, gas-removed from the gas-tank, "spikes-ornails" etc... put in tires, scratches, hub-caps removed/stolen more etc... K, Directed-Conversation: A type of "feedback" where strangers (that shouldn't know anything about the-target(me), talk about the-targets personal-business/affairs around them in public places like gas-stations, stores or anywhere-else. (information gained through the surveillance). This is a fairly-standard OS/GS(Organized-Stalking/Gang-stalking) tactic and happens to many Targets. This is very psychologically-damaging. L, License-plates: A fairly standard tactic, described above, and used on many Targets.
- M, Street-Theater: Also described above; is another standard tactic that involves "setting-up" or "staging" various situations or "skits" that appear normal but are "artificially-created/staged" by the perpetrators. Some examples are..."potential-car-accidents"...vehicles coming at me the wrongway on a one-way street, vehicles driving at-me on the wrong-side of the road with their lights off at night, vehicles trying to run me off the road, various "staged-situations" where I had to take quick-action to avoid a crash, I have had vehicles try to run me over while walking and have actually been hit by vehicles. In one case I "rolled-off" the vehicle. I have not been seriously injured by any of these "contacts" with other vehicles as the vehicles were moving fairly-slowly. Mobbing, more etc... Street-Theater is not only confined to driving-situations and can "happen" any-time-any-place. There is really no-limit to the possibilities and lengths the perpetrators will go to as part of these operations.
- N, PsyOpsTactics:(Psychological-Warfare-Operations-Tactics); also discussed above; again no limit to the possibilities. Many of the above tactics mentioned previously, and-others, fall into this category. It's beyond my capabilities to remember all the PsyOps-Tactics that have been used

- against me in the past 18.5+years of being a Target. Constant "Psychological-Attacks" on a daily basis.
- O, Again, as mentioned above, family-members, friends, neighbors, employers, acquaintances, co-workers, strangers, business-owners, landlords, contractors, street-people etc...and anyone else the perpetrators can get to cooperate (which are many) have been used against me in these operations. The list is nearly endless. This is NOT unusual for a Targeted-Individual.
- P, Gas-lighting: a standard PsyOp tactic where items in someones residence or vehicle etc... are moved around or stolen then "maybe"? put back at a later-date while the target is away. This does considerable psychological-damage to the target and creates paranoia.
- Q, For a time I had no safe place to put anything (I would keep my wallet, keys, phone, pocket-knife on me at all-times)
- R, And, as previously-mentioned, I am "sensitized"(again, Pavlovian) to many "stimuli" i.e. numbers, letters, sounds, colors, objects more...to a "Harassment-Protocol"(for lack of a better-term). These are sophisticated psychological-operations and do considerable-damage to the Target. Torture!
- S, Another tactic often-done-to-me by my perpetrators was... dead animals (squirrels, birds, other-animals, road-kill?) placed on the path/walk to my vehicle or left on the windshield or right outside the driver-door on-the-ground where I couldn't miss-it, usually in the morning. This happened many-times.
- 25, I do not know what electronic-technology was/is being used against-me other than surveillance-and-tracking-technology. It is likely that other technology is being used (as that's the case for most targets).
- 26, Obviously! I was under attack! I knew that! but knew nothing else? Who? Why? What was going on?
- 27, I filed at-least 15-police reports in Connecticut. At first I had an inaccurate and false police-report-written-up by the local Fairfield-Police-Department but when I picked up the report, read-it and confronted the police they changed-it. After that most of the reports I filed were fairly accurate.

- 28, I filed three reports of mail-tampering with the Postmaster-General (federal) in Connecticut.
- 29, I visited the FBI office in Bridgeport-Connecticut twice. I spoke with the same agent both-times and sent them information regarding the targeting. The FBI-agent was polite and treated me well but was not-honest with me as he knew what was going on but said nothing (the agent was finishing my sentences for me, obviously he knew what was going on).
- 30, I do-not come from a military, police or crime-family so I had nothing in my life to prepare-me for what I was experiencing and forced to deal with.
- 31, I cannot put into words the effect/impact of having to deal with this on a constant basis 24/7. It is beyond words. But, I am "trying" to convey, asbest-I-can, my experience in this small-document.
- 32, I have experienced-unimaginable-stress! All Targets do!
- 33, My health was and is severely negatively-affected, damaged by the targeting.
- 34, Every area of my life was and is negatively-impacted.
- 35, In Connecticut I left a job I-had because of the targeting. I didn't know what was going on?
- 36, The targeting has cost me and my family money, damaged my health and almost killed-me.
- 37, I left the country for awhile because of the targeting.
- 38, The targeting interfered with and contaminated my relationships with family-members. Including my relationships with my parents before their deaths.
- 39, My mothers life was negatively-impacted in the last years of her life.
- 40, The targeting interfered with and contaminated my relationships with friends.

- 41, The targeting interfered with and contaminated my relationships with everyone.
- 42, My father was coerced into cooperating with the operation.
- 43, My sister was coerced into cooperating with the operation.
- 44, In Connecticut there was no-place I could go, nothing I could do, where I was-not followed, watched, harassed and/or assaulted in some way.
- 45, Also, nine other (9) states.
- 46, In 2003 I tried leaving Connecticut (I did-not know for how long) thinking I might be able to "get-away" from the targeting. I left for Colorado(driving), a place I had previously lived, but the targeting followed me. I turned-around in Illinois when it became clear to me that I was not going to escape the targeting and drove back to Connecticut. I was crushed and depressed.
- 47, I then knew my targeting was not local but on a larger-scale.
- 48, I survived this horrific-treatment and attacks as best I could while maintaining my commitments and responsibilities to my parents for almost four (4) years alone with little or no help from anyone.
- 49, There were days 25 to 50 incidents might happen in a single day. Sometimes more (some-minor-and-small but still that many "incidents").
- 50, I was under heavy-attack.
- 51, I was in a near constant state of sleeplessness, anxiety, fear, anger, rage and depression.
- 52, My health was failing.
- 53, When I got the chance I would drive thirty-(30)-minutes, 15, 20-miles north, and go into the woods to get some peace and relief. One spot I frequented was Huntington-State-Park in Reading, Bethel, Newtown Connecticut. Sometimes even that did not work as the perpetrators would "mark" some of the spots I would frequent.

- 54, I was constantly trying to figure-out what was going on. And looking for answers-and-relief?
- 55, In February of 2005 my Father had a serious car accident and was not able to return home. That's when I had to legally take over my parents estate and become power-of-attorney for virtually everything including health-care for my parents. I had to do this while living in an Electronic-Concentration-Camp being under constant attack!
- 56, It became my responsibility to manage my fathers medical-affairs, takecare of my mother as well as manage their-estate.
- 57, Doing business (taking over the family-estate, power-of-attorney-for health-care, care-taking etc...) was very difficult because... 1, I had no safe place to put anything (paperwork etc...), and 2, everything I tried to do was interfered-with i.e. things stolen out of the residence, messages sent and not received, faxes sent and-not received, wrong-dates on documents, mail-tampering, messages not returned etc... much-more. The perpetrators tried to interfere with everything I did.
- 58, I tried everything I could think-of and afford to secure the residence and family vehicles. I had partial success with some methods. Including chains, dead-bolts, combination-padlocks and other simple, crude methods. But, I did-not have a lot of money to work with so was limited in what I could do. I was also overwhelmed by the targeting, taking-over the family-estate and care-taking.
- 59, Finally! also in 2005 while on the internet I somehow found some websites on "COVERT-WAR" and "ORGANIZED-STALKING", "GANG-TALKING", "CAUSE-STALKING", there were other terms as well. I had an AH-HA! moment and was finally able to put a word/face on what I was experiencing. I continued to search and I found other websites about what was happening. I have continued to research to this day 14-years later.
- 60, I AM A TARGETED-INDIVIDUAL!

- 61, Almost all these crimes committed against the target(me) happen behind the target/victims back, when they are not there, or from a distance in the most cowardly way possible. The target has no chance or opportunity to confront their attackers face-to-face. No opportunity to defend themselves. All by design of-course. The target can be harassed, abused, assaulted and even killed and the target has no-recourse. If the target complains to the proper-authorities, they are likely taken for a psychiatric-evaluation and labeled mentally-ill. Which makes the situation that much worse for the target/victim. Of-course that's the point! It's an almost perfect-trap. All done by design, intentionally! The Mental-Health-Community cooperates with these torture-programs/operations.
- 62, All the tactics are deceit-based/covert. The perpetrators are "masters-of-deceit".
- 63, Eventually, I came into contact with other targets and got involved in activism. I was not dealing with the "attacks" alone any-more and I had a "name-or-label" for what was happening: Organized-Gang-Stalking-Cointelpro-Operations/Directed-Energy-Weapons-Assaults(DEWs). It was happening to many other people as well. "Targeted-Individuals"!
- 64, I have worked-with and been in contact with many other targets. Some have helped me; some I've been able to help. Though the Target-community is very difficult to deal-with.
- 65, I sent emails and letters to congress-persons, senators, journalists, newspapers other media and more when I was doing activism. Two (2) "projects" I was involved with were "Silent-Holocaust-Day" and "Re-investigation-of-Cointelpro" House-Resolution #1026, proposed by then Congresswoman Cynthia McKinney. Other activism.
- 66, I have a publicly posted story on the internet that I wrote up eleven (11) years ago in Connecticut. It can be accessed by anyone. Simply enter ROBERT WOOD ORGANIZED GANG-STALKING/COINTELPRO into any search-engine and the story I wrote-up eleven-years-ago will come-up.
- 67, It took me a while to learn and figure-out that these are GOVERNMENT-SPONSORED-PROGRAMS/OPERATIONS. There are many names for these government sponsored torture-operations/programs such as COINTELPRO, GANG-STALKING, ORGANIZED-STALKING,

CAUSE-STALKING, MULTI-STALKING, COUNTERINTELLIGENCE-STALKING, CONTRACT-STALKING and more. There is much information regarding these programs such as COINTELPRO and others readily available for anyone willing to do the research. The information at this time and date is plentiful regarding these HORRIFIC-GOVERNMENT-TORTURE-PROGRAMS/OPERATIONS TO ABUSE, TORTURE, CONTROL, NEUTRALIZE, AND DESTROY INNOCENT-PRIVATE-CITIZENS. Many of the psychological-methods/tactics(PsyOps) used on Targeted-Individuals come out of the US-governments/CIA MK ULTRA-mind-control-projects, of which there were at-least 150-subsets. These programs/projects have never-stopped, even after exposure, and have progressed and are more widespread today than ever before. Though under "different-names".

## 68, I AM AN ENEMY OF THE STATE!

- 69, This is happening all across the United-States and globally. I am not alone.
- 70, The "operations/programs" are covert so the government has deniability.
- 71, It is my experience and the experience of other targets as well that the police, fire-department, EMTs are part of these operations/programs. It is treasonous for them to be doing so and they are betraying their public-trust.
- 72, For the US-Government to be running covert-operations on private citizens in The-United-States-of-America is, as-mentioned, treasonous, criminal, illegal. Not to mention Fascist-and-Nazi. The USA is a "Stasi" state-now!
- 73, There are different levels and modes of the targeting. It is not the exact same for all-targets.
- 74, One common-strategy I have personally experienced and seen done to other targets is the perpetrators/government does a profile on the target before the operation-starts, THEY then "Taylor" the operation/program to the target. In essence many targets, including myself, are tortured with their wn psychological-profile.

- 75, These programs/operations are advanced-technology-based.
- 76, The Electromagnetic-Spectrum has been weaponized by the powers-that-be and they have capabilities that range from surveillance to mind-control to torture to outright-murder. All invisible to the naked-eye, which, again, gives the perpetrators, the-government, deniability.
- 77, The tactics and technology used on targets have-been, and are, pulled out of the intelligence-agencies and the military-industrial-complex.
- 78, These are ACTS OF WAR!
- 79, There is a plethora of information regarding the tactics and technology used on targets. The information is not disputable. All the patents for the the technology exist and are-not in question. If one "Googles" TARGETED-INDIVIDUALS-IN-THE-US one will get about 200,000,000(million)-results at the present-time (5/19). There are many targets in the US and abroad.
- 80, Some of the technology includes, but is not limited to, Surveillance, DEWs, (Directed-Energy-Weapons), Voice-To-Skull (V2K or Microwave-Hearing = 5-patented-technologies), RNM (Remote-Neural-Monitoring), EEG-cloning, ELF (Extremely-Low-Frequencies = 3-30 Hz/electromagnetic-spectrum), implants, "bugs", Micro/Nano-chipping, Sensors, AI(Artificial-Intelligence), Supercomputers, much-more...
- 81, The entire USA and much of the world is "networked" so targets cannot get-away.
- 82, As the US is "networked" many Americans knowingly and unknowingly participate in these torture/operations/programs against their fellow-citizens/countrymen. I believe many different methods are used to coerce people to participate in the operations/programs i.e. told lies about the target, a reward-system, intimidation, fear, social-bonding, community/neighborhood-watch-programs, infragard (FBI-program), more etc... The USA is a bona-fide "Stasi" state at this time, 5/2019. Most people will do what an authority-figure tells them to do (Milgram, 1961, 1974).

- 83, I have been Organized/Gang-Stalked/Targeted in Christian-churches and various spiritual-groups.
- 84, I have experienced almost constant "PsyOps" (Psychological-Warfare-Operations-Tactics) and "Cointelpro"-tactics for 18.5+years. As mentioned-above, much of the "psychological-knife-wielding" comes out of the US-Government MK ULTRA mind-control programs. They are used in combination with one's psychological-profile(as-mentioned) to psychologically-torture/destroy the target and/or "Force a Suicide"!
- 85, The "cover" for the targeting is "mental-illness" and the government tries to "funnel" targets into the "mental-health-system". "Political-Psychiatry"(not-new). The mental-health-system cooperates with these operations (profit?).
- 86, I have had a psychiatric-evaluation done and the results were positive, "not-delusional", clean!
- 87, Many targets of these programs have had their lives ruined, are fighting for their lives, been-killed or have committed-suicide(really-murdered!). Again!, one of the goals of these horrific-programs is to "FORCE-A-SUICIDE"! Three (3) target/victims that I personally-worked-with and was close to are not alive anymore. Two of them were doctors. They were not criminals or terrorists and they were murdered by these horrific-covert-government-torture programs/ops in the "land-of-the-free". The name of one of the doctors I worked with is Dr. Deborah Gilmaker, California. Anyone can do an internet search and find information about her. She was brutally, criminally tortured to death. Another target I worked with was named Douglas Greyson, Connecticut.
- 88, It is not a coincidence that I became targeted right after 9/11/2001 as that event allowed the Patriot-Acts, 1,2, various Executive-Orders, eventually NDAA and other legislation to turn the USA into a Surveillance-Military-Stasi-Police-State. That was the very purpose of 9/11/2001.
- 89, I believe(deduced) I was being watched and on some kind of list before 9/11 but the full operation/program/attack against me went into effect right after 9/11/2001(again, not a coincidence!).

- 90, I dealt with being targeted, without knowing what was going on for four (4) years before I found the websites. I honestly don't know how I survived those four-years.
- 91, Since finding the websites and working-with and talking to other targets, doing my own-research(14-years), consultations with other knowledgeable people, deduction etc... I have come to a much better understanding of what has happened to me, other targets nationally, globally, the American-people, the source of the targeting, and what is happening geopolitically both globally and nationally. In a nutshell the planet and country are run by evil-criminal-sociopaths/psychopaths and all these "events" are part of a global-agenda.
- 92, Looking back I can see, as-mentioned-above, that the perpetrators of my operation, The-United-States-Government, got my father (and other family-members) to cooperate in the operation against his own son in his old age. This is not unusual in these operations/programs, as a matter-of-fact it is common. This is psychologically-devastating to the Target/Victim!
- 93, Eventually, I was able to secure the family residence with the help of a security-expert (John Gordon Gordon Security, Huntington, CT) and money which I attained through a reverse-mortgage done to keep my elderly mother out of an institution. But we were still under 24/7 surveillance and the "attacks" on me continued when I left the residence.
- 94, My Father died in October of 2007.
- 95, Also, in 2007, I believe, I participated in a lawsuit with another target by the name of Elizabeth Adams. I sent her information but don't know what happened to the case and was unable to follow-up on it, as there was too-much "happening" for me at the time.
- 96, My Mother died in April of 2011.
- 97, I stayed in Connecticut through March of 2012 partly for a Probate Court-Case.
- 98, I left Connecticut and the country in March of 2012.

- 99, My targeting continued while out of the country.
- 100, I hooked up with another target, a woman I had known for about six (6) years, in Southern-Mexico, Yucatan-Peninsula, not far from Belize.
- 101, This "situation" in Mexico was not going to work (for many reasons) and I came back to the United-States in May of 2012 and "hooked-up" with another target in Duluth, Minnesota. That is how I came to be in Minnesota, where I am now.
- 102, I was in bad shape all-the-way-around when I landed in Minnesota. I needed medical-attention which I received in Minnesota.
- 103, I have had some "blessings" in Minnesota. One of them being that my GP-doctor knew about the targeting and I was able to be honest with her, this was a big help.
- 104, One of the difficulties of being targeted is most people don't believe you when you try to tell them what is happening, they think you're either mentally-ill or fabricating etc... This adds to the psychological-torture of being targeted. All part of the master-plan, of-course! And, "mental-illness" IS the "cover" for the programs/ops!
- 105, I became "careful" about talking about the targeting. It is only the last three-years (2016-2019) that I have gone public and there is now much more information about the targeting then there was when I first became targeted 18.5+-years-ago.
- 106, A few of the symptoms I was experiencing from the targeting when I arrived in Minnesota seven-years-ago were...blood-pressure as high as 130/120, diabetes(no-one-in-my-family-has-ever-had-diabetes), heart-issues, homelessness, anxiety, fear, anger, rage, depression and more. I am recovering from post-traumatic-stress-disorder(PTSD) now.
- 107, I also was able to go into federal-court and win a court-case to get on disability for my back (other-issues) despite interference and sabotage-attempts by my attackers. This was a huge factor in my survival and another one of my blessings here in Minnesota.

- 108, My health has improved quite a bit over time and I try to work hard on taking care of myself and healing. I do-not smoke, drink or take illegal-substances/drugs, I exercise, meditate and pray.
- 109, Needless to say, I do-not-trust the mental-health-system, the police or the government in the United-States.
- 110, I have major-trust issues generally because of the targeting (anyone-would).
- 111, I feel like I have been betrayed by my family, friends, society and country.
- 112, I managed to find employment and worked at a large medical-facility, in Duluth, Essentia-Health, for almost 2.5-years. The targeting continued while at work there. Many employees and coworkers cooperated with the operation/program against me. That assignment ended 5/17/2019. I was "asked-to-leave" for mentioning the targeting to a coworker. It's acceptable for me to be Organized-Gang-Stalked/Targeted/Tortured etc... at work but I'm not allowed to say anything about it! It's a "rigged-game"/system! Also! it horrifies me that people in a hospital-setting would be involved in Organized/Gang-Stalking/Cointelpro/Torture operations/programs against their fellow-employees/coworkers!!!! THAT! personally scares me to death!!! These are supposed to be "caring" people that one can trust with their life! I find this absolutely horrifying!
- 113, I have filed 30-incident-reports with the Duluth-Police-Department since I've been in Minnesota, seven-years.
- 114, I have filled two reports with the Postmaster-General here in Minnesota which makes my total five (5) when added to the three (3) I filed in Connecticut. My mailbox was broken into twice here in Minnesota. A federal-crime.
- 115, My apartment has been invaded many times here in Minnesota.
- 116, I have "hooked-up" with a locksmith I trust here in Duluth and have installed "lock-boxes" with expensive-locks so I have a secure place to put things in my apartment. At least for the moment.

- 117 I have a new security-system in my apartment and there have been no signs of home-invasions in well over a year.
- 118, All my phone-calls and communications are listened to, monitored.
- 119, I am "tagged/marked" everywhere I go.
- 120, There have been well over 100-books written about the targeting.
- 121, As stated above, there is much information about the targeting readily-available to anyone willing to look for it and there are many other targets.
- 122, On the Targeted-Justice website, a group of which I am a member, there is much information from very credible sources i.e... doctors, scientists, researchers, authors, academics, journalists, high-profile-whistle-blowers etc... from the intelligence-agencies, military, government and more. There are many other sources of the facts and information I am stating in this document. The facts I am presenting in this document are true and indisputable. I welcome/challenge anyone to research this information for them-self.
- 123, I consider it a near-miracle that I have survived 18.5+years of targeting and am doing as well as I am.
- 124, I no-longer wish to drive or own a motor-vehicle due to the targeting because... 1, The perpetrators would use the vehicle as a tool for harassment which would cost me money (tampering, vandalism, sabotage etc...), 2, I'm afraid to drive because of the risks involved with the Street-Theater(accidents!).
- 125, I will not ride a motorcycle or bicycle because of the "exposure-risk". I believe someone would "bump-into-me" as has happened many times before.
- 126, I have been the target and enemy of a CRIMINAL-FASCIST-NAZI-MILITARY-STASI-POLICE-STATE for over 18.5+ years in The-United-States-of-America, THE-LAND-OF-THE-FREE!

- 127, This Affidavit, is not complete as it is not possible for me to include everything that has happened to me over the last 18.5+years of being a Targeted-Individual in this one-small-affidavit/document. I have done the best I could to describe, in a synoptic-way, my horrific experiences as a Targeted-Individual-in-The-United-States-of-America.
- 128, The United-States-Government needs to "own-up" and take full-responsibility for these horrific-criminal-torture-programs/operations and publicly admit they are taking place, apologize to targets and compensate them for their suffering. And that would be a nice beginning, start.
- 129, It has made me physically-sick to go-back over all these events and state them in this affidavit.
- 130, I just want to add here at the end of this affidavit/document that if anything "TRAGIC" or "SUSPICIOUS" should "HAPPEN" to me I would-hope that there would be questions asked and a full-investigation done!
- 131, I apologize for any redundancy in this affidavit but certain things I don't mind mentioning more than once.

I declare under penalty of perjury under the laws of the United States and the State of Minnesota that the facts and information herein are true, correct and accurate.
