I've heard about your great reputation for some time now and about two months ago, my husband and I got with ~~Ann-Marie Hoffer~~ through a friend, though it was our getting together on a phone call with her. Ann-Marie through this friend found out that I'm a victim and that's why we got with her, but she is not an attorney for me.

My name is Mrs. Bonnie Kellerby and my spouses name is John Kellerby.
