AFFIDAVIT OF MARLYN T. PAYNE

State of Nevada County of Clark

On this 21 day of fanvary, 2023, Marlyn T. Payne appeared before me, an individual known personally to me the person that affixed her signature to this document below and being first duly sworn on this oath, hereby deposes and says:

I, Marlyn T. Payne, am over the age of 18, and am fully competent in all manner to make this affidavit. I have personal knowledge of the facts herein, and if called as a witness, could and would testify completely thereto.

I am a retired Administrative Assistant at Gilead Sciences.

In September of 1995 I was placed on the Targeted Individual/Watch list after being discharged from the Hansens Disease Center in Carville, Louisiana.

In October of 1995 thru the 21st century, I became a victim of organized gang stalking at the local gym, restaurants, parks, dr appointments, department stores and freeway car accidents. While driving on the freeway, my vehicle failed to stop due to the breaks being severed while parked on a public street. Several years later I was a victim of insurance fraud. As I slowly backed out from a parking space, I was hit from behind by a fast moving vehicle at a strip mall parking lot.

In November of 2009 my husband, my 2 year old daughter and I were in a car accident while driving on the freeway. This resulted in years of PTSD where I could no longer drive a vehicle due to panic attacks.

In 2013 I was hit with direct energy weapons (DEW) in the lower torso area. The excruciating pain had caused me to drop to the floor in tears. I experienced this several times a week (om and off) up until the year of 2020. In 2015 my neighbor (Donna Rohn) was influenced by V2K and killed my dog by poisoning him.

In 2019-2020 I sent out five different petitions to over one thousand individuals and organizations including international profiles via Instagram, Facebook and Twitter to end gang stalking, DEW and V2K abuses against civilians.

In April of 2021 my family and I moved to Nevada where I later realized my next door neighbor (at 432 Bottle Brush Way Henderson NV) was a community based agent. This person along with his family moved in on the same day my family moved in. According to his wife, her husband was transferred to Nevada from an air-force base in Colorado.

In May of 2021 I was hit with DEW in the vaginal area (sexual assault) in attempts to induce orgasm, electric shocks to vaginal area, painful pressure and/or shocks to pelvic bone area, electric shocks and/or painful pressure on bottocks including anal area, intrusive tickling in anal and vaginal area. I emailed one dozen emails to Nevada politicians requesting help to end DEW, V2K and gang stalking.

In June of 2021 I began to feel severe painful shocks and/or painful pressures in both eyes but mainly in the left eye. Shortly after, I began to feel painful golf ball size hits throughout the external part of my head which includes the top, back and temples, painful hits inside of mouth, facial bones, ears (including ringing sounds), painful DEW hits throughout random parts of my body including hands, wrists, arms, feet, knees, thigh, hips (both muscle and skeletal pain). In July of 2021 I had undergone an MRI test which was requested by a Neurologist.

In January of 2023 I sent an email to five different White House politicians requesting help to end DEW, V2K and gang stalking. The organized gang stalking, DEW hits and V2K abuse continues to this day on a daily basis
