

AFFIDAVIT OF ROWENA ESTILLORE

On this 30th day of August 2018, **Rowena Estillore** appeared before me, an individual known personally to me the person that affixed his/her signature to this document below and being first duly sworn on this oath, hereby deposes and says:

I, **Rowena Estillore** am over the age of 18, and am fully competent in all manner to make this affidavit. I have personal knowledge of the facts herein, and if called as a witness, could and would testify completely thereto.

I have a degree in Bachelors of Information in Computer Science with over 20 years of work experience working as contractor/consultant in multinational companies.

1. I am a single mother of 2 being targeted by a group that works or affiliated with government. They use the cointelpro tactic of organized gang stalking, 24/7 intrusive covert surveillance, Voice to Skull (V2K), remote neural monitoring, electronic weapons, microwave weapons, psychotronics via satellite, radar, electronics, cell tower, directed energy, GPS or other means to harass me 24/7 covertly to make someone appear crazy, delusional or to drive them to suicide or to incarcerate them.

I am not a national security threat. More so I am not a terrorist. But why am I in the watchlisted list? My targeting started due to I pissed someone powerful off even though it was not my fault and I was the victim. Their motive is retaliation and revenge/personal vendetta.

2. My targeting started due to what happened in the gym in June 11, 2013 about 3 young men I reported to police for harassment. I have complained to the gym at 24 Hour Fitness in San Ramon when that incident happened. After I reported to police I have been targeted. They put me in their watchlisted, targeted and kill list. They were setting me up and luring in their orgy. When they failed to lure me in their orgy, they started doing 24/7 surveillance, Voice to Skull (V2K) and remote neural monitoring.

I have been subjected to a barrage of crimes such as hacking, cyber attack, cyber bullying, phone tapping, email monitoring, online monitoring, electronic harassment, gang stalking, slander/defamation, identity theft, invasion of privacy, workplace monitoring, workplace sabotage, vandalism and property damage. There are so many men cyber bullying me and I have kept all their pictures as well. I overheard someone said they are from Secret Service but want to know the veracity of that and need help to investigate. There was also one guy (Amr

Azim) that messaged me in LinkedIn before and that time he works as a DoD contractor but now works at the Army and I also kept this as evidence.

The 2 guys I have talked to before that tried to set me up to orgy said he (used the name Ben but later I found out his name is Leandro) is powerful and the other one said he (Ryan Anderson) is from the military/government . They both said they have the power to do everything. I have a hunch that they use the guy named Ben (Leandro) to lure me in to orgy. I have kept all my text, chat, email, pictures of these men.

They invade and sabotage every aspect of my life. They started their propaganda of lies to assassinate my character. I am an innocent civilian and I am not a criminal.

3. Voice to Skull (V2K) technology - I have recordings of the V2K as well. The recording captures the frequency when it gets disrupted if I unplug some electronics like TV, Microwave, Computer/Laptop etc. The voices of the perpetrators can be captured via bone conduction headsets. I hear their voices 24/7 harassing, bullying and persecuting me. Their V2K I even hear how they have recorded and encroached me since 2013 and they describe and nitpick from what I wear, to taking a bath, to what I eat, to my sex life, my kids, my family, my friends, my work etc.

4. Remote Neural Monitoring – They use remote neural monitoring on me to invade and read my thoughts. When I think of something or even it is not intended for something they are thought it is for, I can hear them via V2K then someone would say what is in my thoughts so they capture it. They know where I would go and my next move. There was a time I was logging in to my bank account and via remote neural monitoring and V2K I can hear them getting my user name and password.

5. Gang Stalking - When I go out there are some people gang stalking and some mimic me by copying what I wear and do. One time, my friend even saw the stalker walking back and forth in my home close to the front door. The gang stalking is done by so many normal looking people in a very coordinated fashion, it is hard for victims to collect evidence and law enforcement do not help either.

6. Directed Energy Weapons (DEW) – I am being attacked by DEW 24/7. I experience vomiting, headaches, my body parts jolts, my organs vibrate and they attack my heart, chest, back and legs. I want to save my life for my children as they need a mother. My eyes and vision sometimes get blurry. My health is also getting affected and it weakens my body. This is causing so much emotional distress. This is complete human rights abuse and torture. This is genocide and murder.

7. Invasion of Privacy – They violate my civil rights/liberty and constitutional rights, my freedom, right to live freely, right to be left alone and they invade my privacy. They invade my privacy at home and everywhere I go I am being surveilled and watched. They have surveilled and recorded me since 2013 up to this day which is encroachment and a total invasion of my private life and privacy. This is unconstitutional and illegal.

8. Hacking, Cyber attack, Data Theft, Identity Theft, Email Monitoring, Online Monitoring, Wire/Phone Tapping, Workplace Mobbing, Workplace Monitoring - I worked as a Contractor and in all of my contract jobs from 2014 they surveilled, monitored, spied and stole my data while working at PG&E (2014-2015), Genentech (2015-2016), Rimini (2016-2017) and IBM (2017). They cyber attacked me when I was working at home for IBM as Report Developer. I lost my job and sold my home. I lost a lot of money in the selling of my home due to the sabotage. They sabotage every opportunity for me to get a job. Everywhere I work since 2014, I am being harassed, bullied and mobbed at work. One of my co-worker has mentioned to me that there was someone trying to slander me at work. They hacked and stole all my data saying they will find everything to find any mistakes so they can pin me down and destroy me. They are nitpicking everything and they harass me via V2k and remote neural monitoring by way of persecuting someone on a 24/7 basis. They use my personal information and data to sign up to different sites and use my credit card as well. They monitor my emails, social media and online activities. They also wiretap my phones and each time I have calls after I hung up the phone I always hear the playback recording.

9. Vandalism and Damage to Property - They vandalized and damaged my property by throwing rocks and kicking the fence. My son's car was parked in his Dad's apartment and someone broke the glass. I have called the police when all these crimes occurred, but they never caught who did it.

10. Effects on Family and Friends - Our family is getting affected. My kids only depend on me. They have been trying to kick me out of this country and separate me from my children. I came in this country legally and I even have a lawyer. It affected my relationship with my friends and family because some friends have become distant due to my targeting. My kids have been very affected because we had to sell our house. Now, we have to rent a room and instead of me being with them I was forced to be far from them so we can save money, so they can still go to school.

11. Effects on Employment and Finances - I lost my job and sold my home. I lost a lot of money (300K) in the selling of my home due to the sabotage plus my job I lost income (100K). They sabotage every opportunity for me to get a job.

This is abuse of authority, surveillance abuse, violation of constitutional rights, watchlisting, blacklisting, civil rights and civil liberties abuse, human rights abuse and torture. This abuse of power among some corrupt officials to target innocent people guised as "national security" or "investigation" but the only intent is retaliation to harass, bully, gang stalk, destroy, and murder someone they deem as undesirable or enemy. Until now, I am under 24/7 intrusive covert surveillance with remote neural monitoring, voice to skull and other surveillance technologies they use. I believe I am a whistleblower that is why they are doing this to me.

I declare under the laws of the United States and the State of California that to the best of my knowledge and belief the information herein is true, correct, and complete.
