On this 20th Day of November, 2018, Talina Dupree Simpson appeared before me an individual known personally to me the person that affixed his signature to this document below and being first duly sworn on this oath, hereby deposes and says:

I, Talina Dupree Simpson, am over the age of 18, am fully competent in all manners to make this affidavit. I have personal knowledge of the facts herein, and if called as a witness, could and would testify completely thereto.

1. My name is Talina Dupree Simpson. I am an Opinionated, African-American, Lesbian, Non-Gender Conforming Woman that's been in poverty all of my life and have lived in government subsidized housing apartment buildings all of my life. I am a lover of human beings; believe that all human beings should be treated with dignity and respect whether they are gay or straight, black or white, poor or rich, young or old, american or immigrant, etc. I graduated at the top 10 percent of my class in May 2001 at Withrow High School in Cincinnati, Ohio with a 3.3 GPA. I worked for 15 years before my health conditions started to make things challenging for me physically, which began in 2012. My health conditions started to limit my work tolerance at this time as well. I did jobs such as Fast Food worker, Retail Sales Associate, Clerical Work, and Intern as a Library Assistant, Call Center Agent, Help Desk Associate, Mail Clerk, and some PC Tech work. The year 2012 was also the year I started dealing with acoustic harassment and sexual harassment with Page Tower Apartment Manager William Byrd in my apartment units at Page Tower Apartments Owned by Union Baptist Church and managed by Nelson and Associates. Page Tower Apartments is located at 619 Central Avenue, Cincinnati, Ohio 45202(which is around the corner from Union Baptist Church that owns the building). The main office of Nelson and Associates is located at 5181 Natorp Blvd., Suite 140, Mason, Ohio 45040. Union Baptist Church is located at 405 West 7th Street, Cincinnati, Ohio 45203.
2. I have always been honest with my opinions about religions against LGBTQ People. I never believed that God seen LGBTQ People as a behavior instead of a human being. I don't believe God made any mistakes when he made every human being different or unique. I have expressed my opinions in person and many times over social medias such as Facebook and Myspace in the past.
3. Most of my life, I have worked and/or went to school to be a good, productive U.S. Citizen. I have always encouraged people to do the right thing in life. I have always tried to be there for my mom and 3 brothers the best way I know how to be because I love them and want to be a good role model for them as well.
4. In June 2008, I and my mother moved to Page Tower Apartments, a HUD subsidized hi-rise apartment building designed primarily for low income tenants in poverty. Page Tower Apartments is located at 619 Central Avenue, Cincinnati, Ohio 45202. I had an apartment in apartment unit 412 and mother got an apartment in apartment 1012. At this time, I started to suspect that the Page Tower Apartment Manager, William Byrd, may have been attracted and infatuated with me by how he would look at me and smile every time he would see me or when I would communicate with him about something. When I would get dressed up for an event and William Byrd would see me, he would complement me on how I was dressed by saying things like "You look really nice today." I would notice that when I would discuss something such as the weather with him, he wouldn't mind speaking with me for long periods of time,

however, when I would start to discuss things regarding my residency at Page Tower Apts., he would suddenly become irate, argumentative and dismissive with me all of the sudden.

5. The year 2010, I became more comfortable with my sexual orientation and started to wear my rainbow bracelet and at this time I started cutting my hair military style in some people's opinions. At this time, I also started to attend Gay Pride events and converse more about LGBTQ Topics. This is when the harassment started.
6. In 2010, I would begin to hear laughter and getting stares coming from the Page Tower staff members in the Page Tower office (office is located on the 1st floor of Page Tower Apts.) every time I would enter or exit the building. The staff members would be William Byrd, his assistant Valencia McNeil and a few maintenance workers. There were also tenants at this time that would make comments "Lord help her!" then stare at me. There was also this male neighbor that attempted to pick a fight with me by saying "What you looking at Ugly Dyke Hoe?!" right in front of the Page Tower Office. William Byrd and Valencia McNeil did witness the male neighbor yelling words at me, but they did nothing but watch.
7. I believe it was at this timeframe (year 2010) that William Byrd made me a "Targeted Individual" or TI. I at this time was not aware of such a thing such as a Targeted Individual and Security Services Stalking.

A Targeted Individual is a government term for a person that is being targeted. It is an illegal program of organized crime, although it appears that perpetrators conjecture in their mind that they are doing community policing. Many perpetrators are paid or blackmailed. These perpetrators sometime rationalize or justify in the head they are doing right, although they would never confess in a court of law. Targeted Individuals are the victims of this surreptitious program often using Directed Energy Weapons and Electronic Harassment typically in conjunction with Organized Stalking. Organized Stalking in plain terms is stalking but in a conspiracy organized with others and using wireless technology such as cellphones or handheld devices. Although the public at large does not know about Energy Directed Weapons, this is a fact not disputed by the United States government. A Directed Energy Weapon (DEW) is a ranged weapon system that inflicts damage at a target by emission of highly focused energy, including laser, microwaves and particle beams. The targeting also includes Voice to Skull (V2K) that beams words into the head not using the ears and is usually done in sleep mode similar to dreams.

Targeted Individuals are placed on the Terrorist Watchlist and tracked as "Non-Investigative Subjects," so that local police and sheriffs can be instructed not to assist with their emergency calls.

I am a victim (my mother, 3 brothers, uncles, cousin, friends, past lovers and neighbors are possible victims as well) of this covert horrendous abuse and crimes by corporations and the United States government using this high technology in conjunction with organized stalking. I believe that William Byrd and/or Nelson and Associates have some history of being a part of the security services industry themselves or they have associates that are apart of security services industry that made me the primary Targeted Individual and made my family and my associates Targeted Individuals as well.

8. In September of 2013, the beginning of acoustic harassment in my apartment units started to cumulatively and constantly occur on a daily basis. The noises seem too had been coming from apartment 512, which was above apartment unit, 412. It would sound like someone dropped a book, picked up heavy furniture and forcefully slammed it to the floor, furniture moved or dragged, door slammed, metal object being rolled or bounced on the floor, tapping, scratching and deliberately heavy steps while walking, etc. multiple times per day.

9. Oddly, whenever I would go to another room of the apartment, the noises would seem to follow. Some of these noises also seem to contain threatening words such as “I will shoot her fat ass” from a muffled unknown voice coming from the above apartment unit, 512. Some would include laughter. There would be times that I would come home after having a surgery and have to suffer in silence with pain from my surgeries and deal with irritation and agitation from hearing the constant noises while I’m trying to rest.
10. I suffered with these daily noises for 2 years before management had me change apartment units (from 412 to 912) in 2015. But the noises followed me there.
11. When I was transferred to apartment 912, I would hear loud noises coming from my elder female neighbor to the right of my apartment unit (loud buzzing sounds that I could hear in my bathroom and I could feel the vibrations with my hands between my bathroom wall and bedroom wall). When I would be watching T.V. or cooking in my kitchen, the elder male neighbor across from me would slam his door when he entered or exited his apartment unit, which was several times a day. The male neighbor that lived below me (Apartment 812) would blast his music with bass boost seemingly 10 minutes after I enter my apartment daily. Several times, I would notify Page Tower’s on-shift Security Guards, Page Tower Management and Nelson and Associates, and local police (Cincinnati Police, District 1) but nothing was done about it and there is law against making noises in Cincinnati, Ohio unless its loud music during the evening, according to what local police officers would tell me when I would call them. Starting in year 2015, a few of Page Tower’s Security Guards starting to harass my butch female guests and male best friend, Antonio Huntley that would come to visit me at Page Tower Apartments. These security guards would intentionally pick arguments with my friends to possibly discourage them from coming to visit me. One of the security guards was in her 50s, black, overweight, very loud talking at times and some people referred to her as “Betty.” She was rude to my best friend Antonio whenever she was on shift and he came to visit me. My friend would often report to me that she would give him a hard time before he came up to my apartment. My mother often reported to me how Betty would pick arguments with my brothers, her and her friends when they came to visit her or when they see my mother. I have even experienced her rude attitude and loud voice at times myself. The second security guard was a male in his 50s, overweight, black male that had an angry look on his face when I went pass him around the apartment complex. Every time I would enter or exit the building and this security guard would be on shift, he would always turn his head with a mean grin on his face as if he was disgusted by the sight of me. My cousin reported to me that he referred to me as a man as he picked an argument with her when she visited me for a particular holiday.
12. For the last 8 years, starting in 2010, I and my mother applied to several different government subsidized apartment complexes and housing projects because these apartments were the only type of apartments we could afford due to low income or no income. But we got no callbacks or mailings that we were made aware of.
13. In July of 2018, I begun to feel stuck in an apartment building I hated and didn’t want to be in or associated with no longer. I dealt with so much up to this point. So I decided to file an Ohio Civil Charge and a Cincinnati Civil Charge against William Byrd and Nelson and Associates/Union Baptist Church/Page Tower Apartments in an attempt to get justice for what I have been through and to get help for me and my mother far as getting assistance with finding housing elsewhere. 1 week after I filed these charges, all of the sudden, I get a call from Gateway Plaza Apartments, which happens to be located a few blocks down the street from Page Tower Apartments. Gateway Plaza is also located across the street from the back of Cincinnati City Hall. I found it to be oddly suspicious that the only apartment complex that called me for an apartment in the last 8 years was only a few blocks away from Page Tower Apartments. For the last 5 years, I filed 3-4 housing complaints with HUD against William Byrd and

Page Tower Apartments. I also have contacted the Cincinnati Police LGBTQ Liaison, Home Opportunities Made Equal (HOME), Legal Aid of Cincinnati, OH, ACLU, LAMBDA, Human Rights Campaign (HRC) and various LGBTQ organizations prior to filing the civil charges against Page Tower and William Byrd. I didn't get any assistance from these organizations.

14. I have never had a criminal record a day in my life. I have always been a law-abiding U.S. citizen since birth.
15. I decided to take the apartment offered to me at Gateway Plaza (400 West 9th Street, Apartment 1011, Cincinnati, Ohio 45203) on September 24, 2018. The Acoustic Harassment and Gang Harassment seem too had followed me to my new apartment unit at Gateway Plaza Apartments.
16. The noises didn't start again until a week after I moved into Gateway Plaza. A lot of the types of noises that I heard started to remind me of the same noises I was hearing when I lived at Page Tower Apartments. Again, I began to hear noises such as someone picking up furniture or dumbbells and slamming it to the floor, a book being dropped, furniture being moved or dragged, a metal object being rolled or bounced on the floor, tapping, squeaking, scratching, stumbling, buzzing and deliberately heavy steps while walking coming from the apartment unit above mine (Noises coming from apartment 1111). I would also hear noises' coming from the male neighbor (that seems to be living with his girlfriend) as well that lives on the left side of me in apartment unit 1012. The man in apartment 1012 also slams his door a lot seemingly several times a week.
17. I noticed a few days after I moved into my new apartment at Gateway Plaza, that I didn't have any racks in my oven and some of the electric plugs in my apartment didn't work and so I put in several maintenance work orders, but maintenance workers never came. When I called Edgewood Management (The corporation that owns Gateway Plaza Apartments), that's when a maintenance worker showed up and fixed plugs and gave me oven racks so could use the stove instead of heavily relying on my microwave to cook my food. This was October 3, 2018. This same day, when I was leaving out of Gateway Plaza (around 2pm) and tried to cross the street, a car from the left side of me hit me on the left side of my body. When the car hit me, the right rear view mirror broke when the car crashed into me. The suspected staged car accident left a bruise on the left side of my hip, but luckily no broken bones were seen on the x-ray that I got later that day at Good Samaritan Hospital Emergency Room at 375 Dixmyth Avenue, Cincinnati, Ohio. The guy that hit me happens to be one of my family members' boyfriends (They refer to him as Benny) and he does live at Gateway Plaza Apartments. I was told in the past that Benny is very close with several employees in the Gateway Plaza Management Office and he has lived at Gateway for years. This accident occurred 2 days before my birthday.
18. Over the weekend of October 20-21, 2018, I got tired of hearing the noises above my apartment unit and started calling the police and Gateway on-shift security guards several times. Nothing was done about it and the noises got louder and more constant. I only got a few hours each of those days.
19. October 24th around 9am, 5 minutes after I left out of the Gateway building (for a job interview) I noticed that a guy that I believe lives in apartment 1111 and the guy that lives in apartment 1012 started following me. One of them had his hand in his right pocket of his hoody jacket, staring at me like he had a gun hidden in his pocket that he was planning to use on me. I called the local police about the incident. They noticed in their system that I called the police on them about noise disturbances and the dispatcher at Cincinnati District 1 said "You shouldn't have called the police on them."
20. Til this day, I am still dealing with these Acoustic Harassment-Noise campaigns, Organized stalking and Electronic harassment. I am also currently dealing with some subversion of mail delivery and have not

received my new State ID in the mail and it's been re-issued twice. My mother's health is getting worse and she have also been dealing with noise campaigns, organized stalking and possible electronic harassment.

21. Targeted Individual Programs that are and possibly being administered and effectuated against me and family members and friends:

Acoustic Harassment
Organized Stalking
Electronic Harassment
Directed Energy Weapons

22. Acoustic Harassment- Acoustic Harassment is also referred to as noise campaigns. Noise is a powerful weapon that will be used to destroy a targets quality of life.

Community Stalkers will create unnecessary and excessive noise outside/inside of a Targeted Individual's home. The noise is used to increase the targets anxiety and stress. Stalkers will have the mufflers of their vehicles adjusted to make more noise. They will 'screech' their tires and honk their horns as they pass by your home or pass you on the streets. Emergency vehicles: police cars; ambulances; and firetrucks will pass by sounding their sirens with greater frequency.

The people in the park nearby will make more noise than usual; dogs barking, children yelling...

Community Stalkers often carry out their noise campaign during the night.

One of the objectives is also to deprive the target of sleep. No matter how healthy a person is, no one can function properly with prolonged sleep deprivation. Sleep is essential for the body to repair and heal itself. Without it, the immune system breaks down. Likewise, chronic degenerative diseases and poor general health are associated with sleep deprivation. Targets suffer from memory loss, poor concentration and depression.

23. Organized Stalking- Also known as gang stalking, in more layman's terms, this is stalking, harassment, and intimidation in addition to even more serious crimes by perpetrators in a an organized method which means in a conspiracy with others and using electronic means of communication. From years 2016 through now, I have had several tenants or people associated with Page Tower Apartments and Gateway Plaza Apartments following me when I would leave my apartment. Since 2010, I have been dealing with tenants, security guards and the apartment manager and staff members at Page Tower Apartments bullying me by picking arguments with me on purpose, raising their voices with me and calling me names such as "Ugly, Dyke Hoe." Some tenants would harass me with gospel by saying things such as "Lord Help Her" or "That's a damn shame these gay people don't believe in God." My mother also has been dealing with her next door neighbors listening to her conversation when she has company or when

she is on the phone. My mother's elder neighbor that lives across from her seems to leave out her door every time my mother leaves out of her apartment door.

24. Directed Energy Weapons-Electronic Harassment- A Directed Energy Weapon (DEW) is a ranged weapon system that inflicts damage at a target by emission of highly focused energy, including energy, laser, microwaves and particle beams.

25. Medical- I feel like I keep getting diagnosed with several things and just don't know why. My doctors ask me a lot of questions because they are trying to investigate the causes of my conditions other than the relation to me being overweight. I was diagnosed with Sleep Apnea in 2011 at UC Hospital's Sleep Center in West Chester, Ohio. I was diagnosed with Endometriosis in July of 2017 at UC Hospital at 234 Goodman Street, Cincinnati, Ohio. I was told that I have similar symptoms of Interstitial Cystitis at Good Samaritan's Women's Urogynecology Center that is causing me to go to the bathroom urgently and frequently to the restroom up to 50 times a day. I have been dealing with Depression more often since year 2010. I was diagnosed with Sarcoidosis of the Lungs in 2004 at Good Samaritan Hospital by Doctor Thomas Parker. My Sarcoidosis went into remission in 2005. Now, I have been dealing with ongoing breathing issues since 2011. I have also been diagnosed with Arthritis of the feet, ankles, and knees in year 2016 Good Samaritans' Family Foot Doctor-Podiatry at 6350 Glenway Avenue, Cincinnati, Ohio 45211. I also suffer from Chronic Fatigue.

26. Effect on Family- More family members use to show up at my holiday dinners, but oddly, they stop showing up and this has been like this for years. My oldest brother Darnell Dupree decided this year not to associate with me, our mother, and other 2 brothers all of the sudden. He claims that it's because we don't work and aren't close, but I believe it's something else. My Grandmother passed away 2 days before Christmas of 2012, which made me and my mom sad and depressed. My Uncle has dealt with Depression and Sciatica amongst other things over the years as well. My friend Antonio Huntley stop being friends at the end of 2016 and we have been friends since high school. I remember hearing loud noises when I would visit over the years prior to us stop being friends. My mother seem to be dealing with paranoia often lately and she and I would notice that the ambulance would pass the Page Tower Apartments(where my mother currently lives and has been living since June of 2008, she lives in apartment 1012) building several times a day and this would irritate and agitate her. My mother believes that her elder neighbor that lives across from her keeps leaving out of her door whenever she exits her apartment, floats around her apartment trying to listen to her conversations with others including when I come to visit her. This same woman would leave out of her apartment even when I am exiting my mother's apartment. My uncle (who lives at Page Towers as well) and my cousin (who also lives at Page Tower Apartments) have also been dealing with noise disturbances in their apartments for at least 2 years now.

27. I will never commit suicide or intentionally harm a soul in this world. I have so much to live for and I have always had respect for other human beings not to cause them trouble. This torture has only motivated me to do the right thing even more now than ever. I am a Godly, Loving Woman and I know that God and my Family/Friends love me just the way I am. As I love them and humanity. Targeted Individuals deserve an apology, admittance, and compensation from the United States government for failing us and destroying our health and our lives with these sickening torture programs.

I declare under the laws of the United States and the State of Ohio that to the best of my knowledge and belief the information herein is true, correct and complete.
