

**AFFIDAVIT OF VENETTA DICKENS** \_\_\_\_\_

On this 7th day of July \_\_\_\_\_, 2018, Venetta Renee Dickens \_\_\_\_\_ appeared before me, an individual known personally to me the person that affixed his/her signature to this document below and being first duly sworn on this oath, hereby deposes and says:

I, Venetta Renee Dickens, am over the age of 18, and am fully competent in all manner to make this affidavit. I have personal knowledge of the facts herein, and if called as a witness, could and would testify completely thereto.

1. Have been victim of electronic surveillance and gangstalking for 11 years
2. Have been tortured with Directed Energy Weapons daily since February, 2016
3. Places of residence have been repeatedly broken into on a daily basis since 2014.
4. Electronic harassment/ surveillance, and gangstalking has occurred at all my residences since 2008. I have moved 11 times in the past 11 years trying to evade the gangstalking, break ins, destruction of my property and the vandalism of my residence. My current residence is 833 Providence Glen Dr., Chapel Hill, NC 27514. The Providence Glen Homeowners Association has allowed access to my condo and building. I am attacked by Directed Energy Weapons when standing on balcony, entering/leaving apartment or while walking to the trash dumpster. Any time I am outside for more than 5 minutes on Providence Glen Apt. grounds I am stalked by drones spewing nano particles. Gangstalkers have been allowed access to the condo. The Directed Energy Weapon attacks continue 24/7. Electronic sensors and Directed Energy Weapons are mounted in the trees and shrubbery surrounding my building (photos) and the complex grounds.
5. My cell phones have been repeatedly hacked even though I have changed phones 2-3 times a year and the carriers since 2009. My laptop had a virus inserted currently not working.
6. Was mobbed/gangstalked at workplace in 2014-2015 on a daily basis. My company sent us workers to work remote in January, 2015. I was living in Baltimore, MD my house was broken into every night. Moved to Jacksonville, FLA., Sept. 2015 the electronic harassment/surveillance and gangstalking continued. End result I had to retire early from my position with an international insurance company. The Stalkers initiated use of Directed Energy Weapons February, 2016 attacking me my entire work day. I was in a stationary position sitting at home office computer setup. Unable to move I was a repeatedly attacked during the work day all at intervals during the night while I slept. Forced to sleep in my on the floor in the hallway between my bedroom and and bathroom to escape Directed Energy Attacks.

7. I have photos of burns caused by the Directed Energy Attacks

8. Forced into early retirement June 30, 2017. Organized stalking, hacking of my company computer and Directed Energy Weapon Attacks made it impossible for me to work. The loss of income and quality of life due to the gangstalking, surveillance and directed energy attacks.

9. I have contacted my Sen. Debbie Stabenow (Michigan), Rep. John Conyers, the ACLU, Rep. Elijah Cummings, the Dept. Of Justice, State of Maryland State Attorney Office and the FBI offices in Baltimore, MD And Jacksonville, FLA. No these entities were able to provide me any assistance.

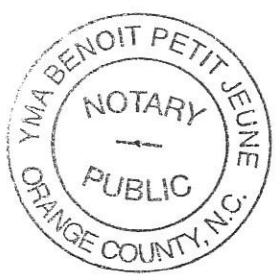
